NARRATIVE:

On 08/30/2019, while off duty, I was traveling south on N Military Trail in the city of West Palm Beach FL 33407, in the #2 (center lane) when I observed a black Toyota Tundra bearing FL license Y82 CRM traveling south bound in the number #1 lane.

I had a clear unobstructed view of a white male driver, later identified by FL DL as Keith Jason Tuman, and a shorter white male passenger. The vehicle was intially in the #3 lane (far right) before accelarating to a high rate of speed then cutting off several vehicles continuig in the #1 lane (far left).

I continued southbound in the #2 lane (center) where i attempted to pass the vehicle when the Tuman started to drift into my lane, I sounded my horn as a warning to the driver.

At this point, I made eye contact with Tuman to ensure he saw me and I proceeded on. Tuman then accelerated, swerved slightly left then intentionally swerved hard right, crashing into my unmarked PBSO vehicle making contact on his passenger side and my driver side.

I immediately slowed down and dialed 911 then pulled behind the vehicle at a safe distance at the intersection of N Military Trail and Roebuck Rd. providing a description for dispatch.

Tuman then turned right and traveled west bound on Roebuck Rd at normal speeds, however failing to maintain his lane of travel.

Tuman then turned right onto Willow Pond traveling northwest, again failing to maintain his lane of travel.



At no point did I loose sight of the vehicle, and Tuman, who I initially observed driving remained in control of the vehicle at all times.

The vehicle came to a stop at Willow Pond and Haverhill where I exited my vehicle and identified myself as a PBSO Deputy with my PBSO issued badge and identification card.

Tuman appeared to attempt to try and focus on my identification, then clearly recognized me as law enforcement stating "I will cooperate Officer, just don't shoot" while attempting to conceal a green Heineken beer can that was in plain view between his legs.

Tuman then stated "I was moving you out the way to get home and take care of my family". The passenger of the vehicle was distraught and spontaneously uttered "I wanted to get out, I wanted to get out, he would'nt let me".

The driver then turned the ignition to the off position and removed the key placing it on the seat. D/S arrived on scene and took charge of the investigation.

D.U.I. PROBABLE CAUSE AFFIDAVIT

ON THE 30TH DAY OF AUGUST 20 19, AT 1615 AM PM

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 8/30/2019 at approximately 1615 hours I was dispatched to investigate a possible motor vehicle accident in the area of North Haverhill Road and Willow Pond Road, West Palm Beach, FL, 33417 in unincorporated Palm Beach County. Prior to my arrival I was provided with the following information. A person who identified himself as Agent [REDACTED] from the Palm Beach County Sheriff's Office informed communications that he was struck by a vehicle and the vehicle fled without providing any information. He advised that he had the vehicle stopped at the above listed location. Upon arrival I made contact with Agent [REDACTED] who advised me of his account of what transpired. He would later provide me with the following supplement probable cause affidavit which placed the defendant, Keith Tuman, in the driver's seat, in actual physical control of the motor vehicle while on a public roadway in the State of Florida. "On 08/30/2019, while off duty, I was traveling south on N Military Trail in the city of West Palm Beach FL 33407, in the #2 (center lane) when I observed a black Toyota Tundra bearing FL license Y82 CRM traveling south bound in the number #1 lane. I had a clear unobstructed view of a white male driver, later identified by FL DL as Keith Jason Tuman, and a shorter white male passenger. Immediately upon making contact with Tuman I noticed the strong odor of an unknown alcoholic beverage emitting from his mouth area, his face was flush red, his eyes were blood shot and glassy,

DRIVER'S STATEMENTS:

his speech was slightly slurred, and his movements were slow. I also noticed a white male on scene who was later identified as Algelio Leone. Leone was the front seat passenger in Tuman's vehicle at the time of the crash and told me that Tuman was driving "crazy" an that he also could smell the alcohol on his breath. After I was concluded with my crash investigation I advised him that I would be conducting a criminal DUI investigation. I brought him in front of my patrol vehicle, were the ground was smooth and level, free of debris and obstructions. I advised Tuman that I noticed several articulable signs of impairment in his person. I advised him of his Miranda warnings on camera, after which he advised he understood. I asked if he was going to participate in roadside tasks and he advised "no". I then advised him of his Taylor warnings, after which he advised he understood and still refused to cooperate with the roadside tasks. Based on the totality of the circumstances Tuman was placed under arrest for operating a motor vehicle

while under the influence of alcohol and or a controlled substance causing or contributing to a crash with property damage and leaving the scene of an accident with property damage. He was placed in PBSO issued handcuffs which were checked for proper fit and double locked. He was then seat belted in the rear of my patrol vehicle and transported to
