On the above date and time, I responded to 739 E. Ocean Ave (Banana Boat) in reference to a theft. This location is in the County of Palm Beach, City of Boynton Beach. While en route, BBPD Dispatch advised an unknown white female left the business with out paying her \$24.00 tab. The female was described as a white female with blond hair wearing a colorful tank top and black shorts.

Upon arrival to the area, I located a a female at E. Ocean Ave and Marina Village matching that exact description, who was later identified as W/F Kelley Maresca. When I made contact with Maresca I could immediately smell an odor of an unknown alcoholic beverage emanating from her person and observed her eyes to be blood shot and glossy. Through my training and experience, these are signs of being intoxicated by an alcoholic substance. I asked Maresca if she was coming from The Banana Boat at which time she advised she had just left there. I explained Maresca that she possibly had an unpaid tab of \$24.00 at The Banana Boat and advised her to return to pay at which time Maresca complied and walked back to the business where I made contact with caller/ manager W/F Stacey Haught (DOB 4/4/84). Haught advised Maresca had multiple drinks and proceeded to walk out on her tab and was cursing at the staff on her way out. Haught advised she did not want to proceed with criminal charges as long as she paid at which time Maresca provided Haught with her credit card and the payment was taken care of. Haught advised she wanted no further involvement with Maresca.

Through further investigation, I was attempting to find out how Maresca was returning home due to the fact that she was intoxicated and it was unsafe for her to be operating a motor vehicle or walking. Maresca requested me to call a cab for her at which time BBPD dispatch contacted Metro Taxi to respond. While waiting for the cab, Maresca began to scream and curse acting belligerent towards me and disturbing the general public in the area. I gave Maresca several verbal commands to calm down and stop yelling at which time she attempted to run away towards to water. At this time, I stepped in front of Maresca to stop her at which time she struck me in the right side of the face with an open palm. I attempted to place Maresca in handcuffs at which time she began to passively resist by pulling away and tensing up her body and legs. Once I was able to place handcuffs on Maresca, she refused to walk and laid on the ground three different times refusing to get up. Ofc. Shepaum responded to the scene to assist and conduct a search of Maresca incident to arrest. Once officers were able to gain control of Maresca, Ofc. Shepaum was assisting me with placing her in the patrol vehicle when Maresca began to activity resist by kicking Ofc. Shepaum multiple time in her lower body. Once Maresca was placed in the patrol vehicle, she continued to scream and kick the cage divider panel in the patrol vehicle.


Once officers arrived at BBPD booking area, Maresca continued to scream and refuse to obey officers verbal commands. While in the booking area, Maresca attempted to stand up multiple times and walk away refusing to listen to officers. While attempting to sit her back down on the booking bench, Maresca continued to push away and attempt to bite me and Ofc. Shepaum multiple times. Maresca also was attempting to scratch me with her nails while trying to gain control of her. Due to Maresca's belligerent behavior and aggression towards officers, she was placed in the restraint chair for both officer safety and her own. While officers were attempting to place her in the restraint chair, Maresca proceeded to kick Ofc. Wagner multiple times in her lower legs. Maresca continued to attempt to escape the restraint chair and kick her legs through out her entire process in the booking area. Both Sgt. Kautz and Dugger responded to the booking area to speak with Maresca and release her from the restraint chair. While removing Maresca from the chair, she immediately tried to get up and force her way out of the cell by Sgt. Dugger. Officers were able to gain control of of Maresca at which time she proceeded to spit on Sgt. Kautz's face and chest area. Maresca was placed back in the restraint chair at this time. None of the above involved officers suffered any life threatening injuries.

Based on the above listed facts, I find probable cause to charge defendant Kelley Maresca with 4 counts of Battery of a law enforcement officer pursuant to FSS 784.07.2B and disorderly intoxication pursuant to FSS 856.011.


Maresca was processed at BBPD and later TOT PBCJ. Nothing further at this time.
