Stokes advised Rombach is his live-in girlfriend for approximately three years. Stokes advised Rombach and he began to have a verbal argument over both party's whereabouts for the duration of the day. Stokes advised Rombach became irate and he proceeded to his/their bedroom to avoid Rombach. Stokes advised he secured the bedroom door in attempts to stay away from Rombach. Stokes advised Rombach entered the bedroom by "breaking" the door down. Stokes advised as Rombach entered the room, she (Rombach) continued to verbally abuse him. Stokes advised he attempted to leave the room and Rombach "grabbed" his arm, not letting him leave. Stokes advised Rombach then began to push, slap and scratch him in an attempt to take possession of his phone. Stokes advised at that time, his mother Tammi Stokes attempting to break up the altercation and was inadvertently battered in her attempt. Stokes advised he retreated to the front porch and waited for Rombach to depart the residence. Stokes advised as Rombach was leaving the residence, Rombach grabbed him by the back of the neck in another attempt to take possession of his cell phone.

I made contact with Tammi Stokes who advised she observed the altercation. Tammi advised she observed Rombach force entry into their bedroom. Tammi advised she observed Rombach pushing, slapping and scratching Stokes. Tammi advised she attempted to intervene and was inadvertently struck by Rombach. Tammi advised she then observed Rombach grab Stokes by the back of the neck as she exited the residence.

I made contact with Rombach who advised she was involved in a verbal altercation with Stokes for the majority of the day. Rombach advised Stokes broke her cell phone and she wanted his phone to leave the residence. Rombach advised Stokes refused to give her the phone and she became irate. Rombach advised she did force entry into the bedroom in an attempt to gather her belongings. Rombach advised as she exited the residence, she did grab Stokes around his neck out of anger. Rombach advised Tammi did grab her around the neck, however Rombach did advise that was during the altercation with Stokes.

I observed several scratches and abrasions on Stokes's arm/neck that were consistent with Stokes, Rombach and Tammi's statement. It should be noted, Stokes advised he did not have trouble breathing when Rombach grabbed his neck.

Through my investigation, I found probable cause to exist for Kelly Rombach in reference to F.S.S 784.03-1A1 Simple Battery (Domestic). Rombach was placed under arrest and transported to the Palm Beach County Jail without incident.
