<p>On September 16, 2017, I responded to 3520 Lakeshore Drive in reference to a domestic disturbance. Upon my arrival, I made contact with the caller/victim Matthew Rice. I also spoke with his daughter/ witness Lauren Rice and his wife/ suspect Kelly Rice. After speaking with each of these individuals, I discovered that the following occurred:</p> <p>At approximately 2100 hours, Kelly arrived home and appeared to be intoxicated. Kelly proceeded to get undressed in her preparation to take a shower. Based on the fact that there were two young children in the residence, her husband Matthew confronted her about walking about the residence in the nude. As a result of that, Kelly became argumentative with Matthew which gained the attention of their 10 year old daughter Lauren Rice. During that time, Kelly became upset and began looking for her vehicle keys so that she could leave the residence. Once Kelly was unable to find her keys, she blamed Matthew of taking them. Note: Based on Matthew's statement, he did not hide vehicle keys, Kelly was so intoxicated that she missed placed where she put them. When Matthew denied taking her vehicle keys, Kelly walked up to Matthew and slapped him once on the left side of his face with her open hand. When Matthew threatened to call the police, Kelly fled the residence on foot and was later apprehended by Officer Douglas just north of the incident location on Lakeshore Drive.</p> <p>Matthew gave a recorded statement regarding this incident. Photos of Matthew's face was taken and placed into evidence. There was in fact redness on the left cheek of Matthew's face.</p> <p>Lauren Rice gave a verbal statement but was reluctant for it to be recorded. Lauren witnessed Kelly slap her father, Matthew.</p>

Post Miranda, I asked Kelly, why did she slap Matthew? She stated that she slapped him because he deserved it. I then asked Kelly did Matthew hit her back in response, she said "No." This statement was not recorded; however, it was witnessed by Officer Douglas and myself.

Based on the above described facts of this case, Kelly was charged with one count of Simple Battery (Domestic). Kelly was processed and later turned over to the Palm Beach County jail. Matthew was given a Victim's Right Pamphlet. DCF was notified via the Online regarding the facts of this incident.
