

<b>PROBABLE CAUSE STATEMENT</b>	<p>On Monday, January 15th, 2017 I responded to 2401 Beach Court, Sands Hotel, Riviera Beach Florida 33404 in reference to a trespass of a white female. Upon arrival contact was made with Joseph, the property manager for the sands hotel. Joseph stated that a white female named Kelly Heffers was acting belligerently, yelling and screaming in front of the hotel. Joseph advised that he wanted Kelly to leave the property and be issued a trespass warning.</p> <p>When contact was made with Heffers I advised her that Joseph, the property manager, did not want Heffers back onto the property. I gave Heffers an opportunity to retrieve any belongings she may have had on the property before issuing the trespass warning.</p> <p>After her property was recovered, and we were approaching the entrance, Heffers began to resist Officers. Heffers postured up near the entrance of the establishment and refused to leave. Heffers stated; "I AM NOT GOING ANYWHERE!" After several commands to leave, Heffers was physically assisted and began to actively resist officers. Heffers began pushing and twisting her arms to make it difficult for Officers to effect the arrest.</p> <p>Kelly R. Heffers was arrested and charged with Trespass After Warning and Resisting Arrest Without Violence. Heffers was transported to Riviera Beach Police Department booking for processing and later transported to Palm Beach County Jail.</p>
