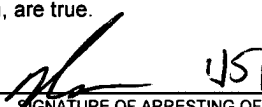
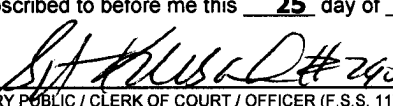

Upon my arrival, I observed a white male, later identified via Florida driver's license as Kendall Fore, walking into 801 8th Lane. I approached the exterior fenced-in perimeter of the home at which point in time I heard a male yelling, a female crying and glass breaking inside the home. I then approached the front door, announced "Palm Beach Gardens Police" and opened the front door which was unlocked. At that point in time, Fore approached the door and exited into the patio area. Fore was placed into handcuffs, which were double locked and checked for proper spacing, while we conducted our investigation. I then entered the residence and observed a white female, later identified via Florida driver's license as Courtney Gomez, sitting on the floor in the kitchen crying with a bloody ankle with what appeared to be multiple small cuts and swelling to the right side of her face from her eye to her chin.

I first spoke with Gomez who advised the following on a sworn verbal statement; Gomez advised she had been waiting for Fore to come home from work and he was running late. When Fore arrived home Gomez met Fore in the patio area. Gomez advised Fore appeared angry and they began to argue because Gomez accused him of seeing another woman. Gomez stated that Fore then punched her in the face with a closed fist and dragged her into the home by her arm. Once inside, Gomez stated the arguing continued and Fore punched her again and continued to yell at her, accusing her of being drunk. Gomez advised she did not recall anything further, just police arrival on scene.

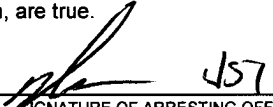
I then spoke with Fore, who was read his Miranda warnings from a preprinted card, advised he understood and still wished to speak with me. Fore advised he was on his way home from work when he realized he forgot his phone there, so he had to turn around to retrieve it. Once he retrieved his phone he realized he had missed calls and texts from Gomez who was upset because he was late. Gomez had stated over text that she had gotten them a 6-pack of beer for them both but had drank it all because he was late. Once he arrived home he was met outside by Gomez who advised she was going to get ice cream for them both and their children. Fore advised he believed Gomez was intoxicated and didn't want her to drive, so he grabbed her by her arm and got her out of the vehicle. Fore then grabbed her purse and keys and hid them so she wouldn't drive. When Fore went back out to the car Gomez was still sitting in it, so he again tried to grab her and get her out of the vehicle. Fore then advised he started to walk inside to get his things and leave when he noticed that Gomez had fallen but couldn't advise how or where she fell. Fore said once they were both inside the arguing continued and Gomez tried to leave, so he grabbed her by her shirt and pulled, ripping her shirt and bra off and Police arrived shortly thereafter. Let it be noted, Fore did change his story multiple times while providing a statement.

Inside of the residence I observed items scattered throughout the kitchen, to include a cabinet drawer that had been pulled out and was dumped onto the floor. There was also a shattered beer bottle on the floor. I also observed the above mentioned ripped shirt and bra laying on the floor in the kitchen. I observed an infant child (Kendall Fore 01/04/2018) who was in the main room of the home in a rocker, within sight and hearing range of the incident. Also, Stella Gomez's (07/26/2013) room was down the hall from the kitchen. Ofc Batista #439 advised he spoke with Stella who advised she did hear the arguing and went to check on her mom. Stella advised she did not see any of the altercation, only heard it. Also, both subjects did have the odor of alcohol emanating from their person as they talked.

Based on my investigation, I do find probable cause to charge Kendall Fore with one count of domestic battery contrary to F.S.S. 784.03(1) (A) (1).
