

	<p>observed one male standing directly behind him with a robe on, who was later identified as Palmer Pekarek, W/M DOB 06/18/1970. Both parties appeared calm and upset and were separated at this time.</p> <p>I made contact with Greer, who appeared to have multiple cuts on his back and left calf. Greer advised me that they had gotten married three weeks ago and incidents like this are not normal. Greer stated that Pekarek and himself were at a rehearsal dinner party this evening. Greer stated that as they were leaving the party he observed Pekarek kissing another male. Greer stated that he confronted Pekarek when they returned back to the hotel and was unable to get a response from him. At this time both parties got into bed. Greer stated he attempted to continue speaking to Pekarek in bed and subsequently dumped his glass of water on Pekarek. After Greer dumped the water on Pekarek the altercation escalated into a pushing match. Greer stated during the pushing match he got pushed against a wall where there was a large picture in a glass frame hanging on the wall. Greer stated when he hit the wall the picture fell onto his shoulder and broke, leaving multiple cut marks on his back and calf.</p> <p>I made contact with Pekarek, who appeared to have one minor cut on his left thumb. Pekarek stated after the rehearsal dinner party, they were transported back to the hotel via a trolley. Greer advised that he observed Pekarek kissing another male on the trolley. Upon returning to the hotel room, Greer confronted him about kissing another male. Pekarek stated that he did not kiss another male while on the trolley, he was gazing out at the moon. Pekarek stated at this time he did not want to get into a confrontation so he walked to the front desk to get another room. Pekarek stated he was advised the hotel was full and returned to his room and went directly to bed. Pekarek stated that Greer pushed him off of the bed onto the floor between the bed and the wall and started close fisted punching him. Pekarek stated he attempted to push Greer off of him and that is when Greer hit the wall and the picture fell on him.</p> <p>Based on my interviews and the fact that there was physical evidence, Greer was arrested for F.S.S 784.03 (1) Domestic Battery. Greer was transported to Palm Beach Police Department while I completed the arrest packet. Greer was transported to Palm Beach County Jail without incident. Pekarek was provided a palm beach police domestic violence packet.</p>
