On September 7 2019 at 0052 Hrs. I was dispatched to 10998 Okeechobee Blvd (Brass Ring Pub) in reference to a disturbance. Prior to my arrival PBSO dispatch advised that a male didn't want to leave the establishment upon telling him they were closing and had to leave. Upon arrival I observed the manager of the establishment wave to me pointing to a gentlemen that was approaching his parked car. I turned my vehicle around and went to make contact with the gentlemen in question. I observed a later to be identified Kenneth Hall get in the driver seat of his vehicle. I then observed Kenneth start the vehicle and put it in reverse like he was attempting to leave the area. I then proceeded to activate my emergency lights and conducted a traffic stop. Kenneth then put the vehicle in park and immediately exited. I told Kenneth that I wanted to speak to him and he start saying "this asshole called you for no reason", pointing to the manager that was close by. I observed Kenneth's eyes very bloodshot and glassy. When I asked Kenneth for his ID he immediately became irate stating that his son in law is a law enforcement officer and we should be ashamed of what we are doing. At that point I called for a DUI unit to investigate it further. DUI investigator [redacted] arrived on scene and the case was turned over to him.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law

I made contact with the driver as he stood next to his vehicle. He was later identified as Kenneth Edward Hall by his Florida driver license. During my interview I noticed his eyes were red, watery and glossy. His cheeks were flushed and his mouth was dry. His movements were slow, calculated and lethargic. He was wearing a green shirt, blue jeans and brown shoes. I could smell a strong odor of an unknown alcoholic beverage emanating from his breath that intensified when he spoke. I told the driver I had a suspicion that he had been drinking an unspecified amount of alcoholic beverages. He told me he drank earlier. I asked if he would consent to performing Standardized Field Sobriety Evaluations (SFSTs) for the purpose of determining if he was impaired while operating a motor vehicle. He consented to performing the SFSTs. Prior to his performance I asked if he had any physical problems with his body that would inhibit him from performing light physical movements. I also asked if he was on medication. The defendant conveyed he neither had anything wrong with him physically, nor was he taking medication. I escorted him to a smooth and level surface inside the parking lot. This area was well lighted by pole street lights. I placed a yellow strip of tape on the roadway that formed a line. I asked him to acknowledge the line. He successfully did so by placing his left foot on it when prompted to do so. The following SFSTs were explained, demonstrated and acknowledged by him prior to his performance: HGN, The Walk and Turn, The One Leg Stand, The Finger to Nose and The Romberg Alphabet Recitation. His deficiencies were recorded on another form on this worksheet. At the conclusion of the SFSTs, coupled with the officer's observation of the defendant's vehicle in motion and my observation of personal indicators of impairment exhibited by the defendant, probable cause was established for DUI. I told the defendant he was being placed under lawful arrest for DUI. The defendant was searched and handcuffed (double locked and checked for tightness) prior to being seated into the rear of my patrol car. Afterward I began transport to the main jail breath analysis facility for further processing. While en route to this location he was adamant about not being given the opportunity to give breath samples. He became enraged and cursed me the entire trip to the facility. Upon our arrival I escorted the defendant into the facility and began a 20 minute observation period. During this time the defendant did not ingest anything into his body orally or otherwise. Neither did he regurgitate. I escorted him into the testing room and asked him to provide breath samples for the purpose of determining his alcohol content. He refused.

On Saturday, September 7, 2019 at approximately 0100 hour, I responded to The Brass Ring Restaurant, located at 10998 Okeechobee Boulevard, Royal Palm Beach (Palm Beach County) Florida to assist Deputy C. Tiburcio with a traffic stop that involved a possible drunk driver. Upon my arrival I noticed I blue mustang, bearing current Florida license plates "IA2477", pulled into a parking space inside the parking lot of the previous mentioned restaurant. D/S Tiburcio and back up deputies were standing next to the vehicle with a white male subject. I met with D/S Tiburcio who told me he was dispatched to the restaurant regarding a disturbance complaint. He ultimately made contact with the defendant whom he saw backing his vehicle in the parking lot. He suspected the subject to had been drinking an unspecified amount of unknown alcoholic beverages and asked that I a DUI unit respond to assess the driver for possibly being impaired. D/S Tiburcio wrote a sworn witness statement on a probable cause affidavit regarding his involvement with this case.

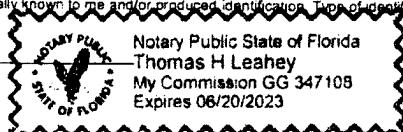

Other Observations:

Subject was asked to stand with their feet together and place their hands by their side. They were asked to focus on the stimulus and follow it with their eyes. Lastly they were told not to move their head to assist in following the stimulus with their eyes. Subject showed equal pupil size that tracked equally. Both eyes lacked a smooth pursuit. Subject continued to move his head and would not look at the stimulus during gazed evoke. I saw an onset of Nystagmus prior to 45 degrees in both eyes. Subject swayed while performing this task.

WALK & TURN:

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE WALK AND TURN. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. THE DEFENDANT ACKNOWLEDGED THE INSTRUCTIONS PRIOR TO PERFORMING THIS TASK: Subject was unable to maintain his balance while placed in the instructional position. He swayed and ultimately abandoned the position. During his performance he failed to keep his arms by his side, he did not touch heel to toe, he stepped off the line, he was unable to maintain his balance while walking the line, he turned improperly and took an incorrect number of steps

ONE LEG STAND:

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE ONE LEG STAND. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. THE DEFENDANT ACKNOWLEDGED THE INSTRUCTIONS PRIOR TO PERFORMING THIS TASK: Subject swayed during his performance, he did not keep his arms by his side, he dropped his foot on the pavement

FINGER TO NOSE:

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE FINGER TO NOSE. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. THE DEFENDANT ACKNOWLEDGED THE INSTRUCTIONS PRIOR TO PERFORMING THIS TASK: Subject swayed while performing this task, he missed touching the tip of his finger to the tip of his nose 4 out of six times, he failed to return his arms to his side after making contact with his nose and erred attempts. He flinched the wrong hand on the counter request

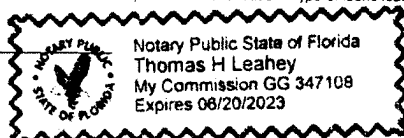
