Narrative:

On the above date and time, I responded to 3339 S.Federal Hwy unit H in reference to a domestic dispute. This location is in the County of Palm Beach, City of Boynton Beach.

Upon arrival, I made contact with victim W/F Marcela Castillo Siu (DOB 6/20/88). Siu explained earlier in the evening she and her husband W/M Kenneth Clarke (DOB 2/1/70) were in a verbal altercation at Walmart over on going relationship issues causing Siu to leave Walmart and walk back home. When Siu arrived back home, k.Clarke and his mother W/F Patsy Clarke (DOB 10/30/46) were back at the residence waiting for her. Siu explained while she was in the kitchen, Patsy began to argue with her over food and the fact that she is a vegetarian. Siu advised she became up set with her mother-in-law so she told her that if she keeps eating meat, she is going to die because its poison which caused Patsy to become upset and begin crying. At this time, Siu explained k.Clarke stepped in and told both of them to stop and began to yell at Siu to apologize to his mother, but, Siu refused. Siu advised k.Clarke stated "apologize to my mother or leave", at which time Siu stated she was going to leave the residence and leave k.Clarke. While the verbal altercation ensued, Siu went upstairs to gather belongings and k.Clarke followed.

When Siu walked upstairs and attempted to enter her bedroom to retrieve her belongings, k.Clarke blocked the doorway denying her access to the room. k.Clarke stated "you have to leave now your not going in the bedroom to get anything", but Siu refused to leave with out any clothing or her cell phone. At this time, Siu attempted to force her way by k.Clarke to gain entry by attempting to squeeze in between him and the door frame, at which time k.Clarke pushed her away from the doorway causing her to fall and strike the wall with her right elbow. Siu advised when she fell against the wall, it left a slight scuff mark on her right elbow/ forearm area. At this time, Siu left the residence and notified BBPD

I made contact with k.Clarke who corroborated a similar story. k.Clarke explained that Siu and his mother were in a verbal altercation over food which he tired to deescalate. k.Clarke advised he told Siu to apologize to his mother and stop being rude to her, but Siu refused to apologize and began to yell at him causing them to get into an argument. k.Clarke explained Siu threatened to leave him for good and threw a box of rice from dinner onto the kitchen floor. At this time, k.Clarke advised Siu " if your going to act like that, then leave the house now". Siu advised she was leaving the residence and began to walk upstairs at which time k.Clarke followed. k.Clarke advised when they got to the bedroom door they proceeded to argue and he blocked the doorway so Siu could not enter. k.Clarke explained he blocked the doorway because he wanted her to get the suitcase downstairs first so she could pack all her belongings, not just take a few things, but Siu refused to do so. k.Clarke advised Siu attempted to talk him into letting her into the bedroom which he continued to refuse causing Siu to give up and leave the residence. k.Clarke denied any type of physical altercation or ever pushing Siu.

I made contact with Patsy who explained that both Siu and k.Clarke were arguing because Siu was rude to her and would not apologize. Patsy advised at no time did she observe any physical altercation. It should be noted, Patsy advised she did not want to be involved with the incident and provided little information. Through further investigation, I observed a scuff mark on Siu's right elbow/forearm area that appeared to be fresh with small pieces of superficial skin peeled back as if she had rubbed against a rough surface. The injury appeared to be consistent with Siu's elbow striking a wall as she was pushed. Siu's injury was minor and she denied any medical attention. I did not observe any injuries to k.Clarke. At this time, I advised k.Clarke he was under arrest for simple battery, placed him in handcuffs, checked for tights, and Siu and I locked them.

Based on the above listed facts, I find probable cause to charge defendant Kenneth Clarke with simple

battery pursuant to FSS 784.03.1A1.

Photos were taken of both parties and submitted to BBPD evidence per procedure. Siu completed both a BBPD exemption form and a sworn statement. Siu was issued a victim rights packet and a case card for future reference. k.Clarke was transported to BBPD for processing and later TOT PBCJ. Nothing further at this time.
