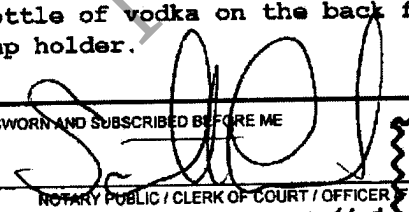
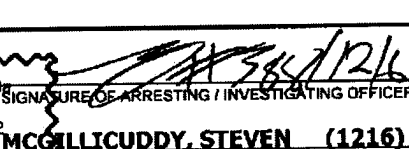

On the <u>10</u> day of <u>June</u>, <u>2019</u> at <u>23:23</u> (Specifically include facts constituting cause for arrest.) On 6/10/2019 at approximately 2251 hrs, I was at the intersection at Palm Road and W Indiantown Road, facing northbound. I observed that the east bound left hand turn lane had a steady red light. I observed as a black GMC Acadia (VEHICLE-1) bearing FL tag JLF-R64 pulled up to the light, put its' hazard lights on and made a hard u-turn against the steady red light. The vehicle then continued west bound. I followed the vehicle to the steady west bound red light at W Indiantown Road and Central Boulevard, where I observed the vehicle stopped almost in the middle of the intersection. At this time I noticed unsafe equipment on the vehicle, as the right rear quarter panel was popped out, and the right rear tire was blown out completely to the rim. As the light turned green I activated my overhead red/blue lights. The vehicle failed to yield as it approached the I-95 south bound on ramp. I activated my siren at this point and toggled through siren patterns. The vehicle continued south bound and continued to fail to yield to my lawful command to stop. As we were traveling onto the on ramp, the vehicle was swerving all over the road; coupled with the failure to yield and aggressive lane changes created a willful and wanton disregard for the safety of others. The vehicle stopped at the top of the I95 ramp at which time a high risk stop was conducted. It took a long period of time calling for the driver to exit over my PA system. The driver, now identified as Kevin Mulqueen (DEFENDANT) eventually stepped out. He was highly unsteady on his feet, had a long stare, and had urinated himself. Mulqueen had extreme difficulty in listening to commands. Eventually with the assistance of multiple officers Mulqueen was called back to us and detained. I observed that he had bright red cheeks, glassy bloodshot eyes and spoke with slurred speech. I detected the odor of alcoholic beverage emitting from his breath which intensified when he spoke. Upon clearing the vehicle, I observed an open bottle of vodka on the back floor board and an open container of listerine in the front cup holder.

	I approached Mulqueen and asked him where he thought he was coming from. He stated that he was coming from North Carolina and believed that he was in Stuart. He advised on a scale from 1-10 of intoxication that he was at a three. He could not explain the blown out tire. I asked him if he would consent to field sobriety exercises and he agreed. I attempted to have him perform HGN (pen light task), however he was so unsteady on his feet that Officer Piazza had to hold his arm to prevent him from falling over. Once I began manipulating the stimulus, he could not perform even basic task tracing due to his level of apparent impairment. I had Palm Beach County Fire Rescue evaluate him for medical conditions and they advised that he was not suffering from any medical condition that would be causing his behavior/indicators of impairment. Due to the the fact that Mulqueen had to be handcuffed on scene and I was not sure yet where the damage to the vehicle came from, Mulqueen was read Miranda on scene by me. I placed Mulqueen under arrest for DUI and transported him to the DUI Breath Alcohol Testing center, where I placed him under the 20 minute observation period where I did not observe him consume nor regurgitate anything. We then went on video with BAT Technician Palmer (ID 24520) and I requested a breath sample from Mulqueen. He agreed and provided samples of .207 and .208. I read him his Miranda warning again and he advised me that he had a combination of drinks tonight and was a 4 on a scale of 1-10 of intoxication. Additionally, he conceded that he was impaired. I then completed my paperwork and booked Mulqueen into the Palm Beach County jail. BWC.
