

Officer Kresse (ID #626) responded as back up.</p> <p>Upon arrival I met with the victim, [REDACTED] stated that he was in the breakfast line in the Ramada's restaurant and set his coffee down on a table and when he returned to the line a white male, later identified as Kevin M. Sullivan started arguing with him about cutting in line. [REDACTED] stated that Sullivan then pushed him with both hands causing [REDACTED] to fall backwards onto the floor. [REDACTED] incurred no injuries. [REDACTED] described Sullivan as a stocky white male with short graying hair and a short cropped full beard with a New York accent. [REDACTED] stated he wished to pursue charges against Sullivan. Officer Kresse video recorded [REDACTED] statement via her department issued body camera.</p> <p>Officer Kresse interviewed independent witness w/m Brady P. Mulligan and video recorded his statement via her department issued body camera. Mulligan stated he heard [REDACTED] and Sullivan arguing and saw Sullivan push [REDACTED] with both hands, causing [REDACTED] to fall backwards onto the ground. Officer Kresse also interviewed independent witness w/m Gerald O'Brian and video recorded his statement via her department issued body camera. O'Brian also stated that he heard and saw [REDACTED] and Sullivan arguing and saw Sullivan push [REDACTED] to the ground with both hands. There were other independent witnesses that observed the incident but wished to remain anonymous. All the witnesses described Sullivan as a stocky white male with short graying hair, a short cropped full beard and wearing a blue tank top. The witnesses also stated that Sullivan left the restaurant and went back to his room on the first floor, possibly room #127. Sullivan's wife, w/f Donna Sullivan, witnessed the incident but declined to give a statement.</p>

	<p>Officer Kresse and I went to room #127 and knocked on the door. Sullivan answered the door and stepped outside to speak with me. Sullivan was a white male with gray hair, a close cropped gray beard and was wearing a blue tank top. I asked Sullivan to tell me what happened. Sullivan stated that he was in line and saw [REDACTED] cut into the line. Sullivan told me he confronted [REDACTED] and told him, "There's a line." Sullivan stated that [REDACTED] responded that he had already been in line. Sullivan stated [REDACTED] started mouthing off and stated, "You want to take a leap?" Sullivan stated that when [REDACTED] said this he raised his closed fists in front of him and it appeared that [REDACTED] was going to fight him. Sullivan told me, "So I pushed him with my hands and he fell to the ground." Sullivan said he admits he was the primary aggressor by first pushing [REDACTED] but said it appeared [REDACTED] was going to hit him and so he took defensive action. Sullivan repeated multiple times that he knew I would have to arrest him since he was the one who pushed [REDACTED] without [REDACTED] touching him. This conversation was video recorded on Officer Kresse's department issued body camera.</p> <p>[REDACTED] who was in the lobby with Officer Kresse, positively identified Sullivan to Officer Kresse as the man who argued with him and pushed him to the ground against his will. Investigations revealed that Kevin M. Sullivan committed Simple Battery, contrary to F.S.S. 784.03(1), and was the sole and primary aggressor when he used his open hands to push the victim, Richard A. [REDACTED] to the ground against the will of [REDACTED] I arrested Sullivan and, due to his stature, placed him two sets of handcuffs linked together. Both sets of handcuffs were checked for tightness and double locked. I transported Sullivan to the Boca Raton Police Department Jail for processing. Sullivan was then turned over to the Palm Beach County Sheriff's Office Jail.</p>
