<p>On 11/16/16/ at approximately 1545 hours, I arrived at the 4500 block to assist Deputy James Breslin with a traffic stop that was already in progress. Upon arrival, Deputy Breslin told me the following:          At approximately 1525 hours, he was westbound on Donald Ross Rd behind a gold Lexus 4 door car. The car was displaying Florida tag Y05DTT. Deputy Breslin saw through the untinted rear window that the front seat passenger was not wearing the seat belt. The clasp section of the belt was clearly visible, hanging to the right of the passenger near the B pillar. As Deputy Breslin turned on his emergency lights to affect a traffic stop, the driver continued to drive west in the same lane. Deputy Breslin used his siren to gain the driver's attention and pointed for him to move to the right shoulder. The driver responded instead, by moving one lane to the left. Deputy Breslin again tried the siren and pointing to get the driver to pull to the right shoulder, but he moved another lane left to the left turn lane at Military Trail. When the driver stopped, Deputy Breslin made contact with him told him the reason for the stop (that his adult passenger was not wearing a seatbelt). Deputy Breslin obtained the driver's license to establish identity and ownership of the car, and later got the passengers information to establish his identity. It was then that Deputy Breslin smelled the odor of marijuana coming from the interior of the car and the odor was immediately recognizable to him, based on his training and experience, as marijuana. Deputy Breslin asked the driver if had marijuana. The driver said he did. Deputy Breslin asked if it was a little or a lot, and the driver said it was about 2 ounces. The driver then reached from the front seat area, back through the rear seat, and into an orange Nike shoe box that was in the trunk (he accessed the trunk from inside the car via the arm rest trunk access). He removed a clear plastic sandwich sized bag that contained marijuana and handed to Deputy Breslin. It was at that time that Agent Breslin called me to the scene to assist. Deputy Breslin also stated that prior to my arrival, he issued the passenger, Michael Panebianco, a citation for Adult Passenger Not Wearing a Seatbelt (after he verbally provided his SS# as he did not have ID on him, Investigation revealed a FL DL # P515558933780 and picture.)          At that time, I field tested the marijuana and the results were positive. The weight of the marijuana was 88 grams. I read the Miranda Warnings to Khaled Abukhalil and he stated he understood them. I then asked him if the marijuana belonged to him or to his passenger, Michael Panebianco. Abukhalil stated that the marijuana belonged to him only and that his passenger did not know it was in the vehicle. I asked Michael Panebianco if the marijuana belonged to him. Based on the above facts, I determined that Khaled Abukhalil was unlawfully and knowingly in actual or constructive possession of more than 20 grams of a material, compound, mixture or preparation which contained cannabis, commonly known as marijuana, a controlled substance, contrary to Florida Statute 893.13(6)(a).</p>
