Narrative:

On the above date and time I was dispatched [REDACTED] in reference to a disturbance in which a female and male were arguing in the parking lot. It should be noted that I previously responded to this location in reference to BBPD case# 17-047213 in which the caller observed a female striking a male inside a black Hyundai vehicle. All involved parties were gone upon my arrival. Reference this current case, upon my arrival to the area I met with [REDACTED] and Kimberley Martinson and separated both parties.

Upon speaking with [REDACTED] he advised that he had been in a verbal argument with Martinson, [REDACTED] who he has [REDACTED] stated that they had just returned to the above residence from dinner and they were in their vehicle, a black Hyundai (FL Tag IAAW04) when the argument was taking place. Martinson was in the drivers seat and [REDACTED] was in the front passenger seat. [REDACTED] advised that Martinson became angry when he suggested that they continue their date at a location in West Palm Beach [REDACTED] told me that Martinson told him to get out of the vehicle which he stated that he refused to do. [REDACTED] then advised that Martinson began to throw his belongings outside of the vehicle and began striking him in his left arm and left ribcage area with a closed fist. Through a visual observation I did observe that [REDACTED] did in fact have bruising on the left side of his torso that appeared consistent with his statement. I did not observe any signs of physical injuries on [REDACTED]'s left arm where he stated that he was struck. Photographs of [REDACTED]'s injuries were taken and later submitted into BBPD evidence via ADAMS. [REDACTED] declined any medical attention that was offered. [REDACTED] provided a sworn taped statement captured on my Body Worn Camera (BWC) (2125-2128 hours).

I then met with Martinson. Martinson advised me that she and [REDACTED] had been at dinner when [REDACTED] began to argue with her. Martinson stated that she did not "want to deal" with [REDACTED] arguing with her so she attempted to drop him off at his residence. Martinson stated that she asked [REDACTED] to exit her vehicle which he refused to do. Martinson stated that she then parked the vehicle and began yelling. Martinson stated that [REDACTED] grabbed her by the jaw in an attempt to stop her from yelling. I then asked Martinson if she struck [REDACTED] which she stated that she did, but that it was in self-defense. Through a visual observation of Martinson I did not observe and physical bruising to her jaw where she advised she was forcefully grabbed by [REDACTED]. Photographs were taken of Martinson and submitted into BBPD evidence via ADAMS. Martinson declined any medical attention that was offered. Martinson provided a sworn taped statement captured on my BWC (2131-2133 hours).

Lastly I met with a witness Steven Hubers. Hubers advised me that he was in his apartment (2917 Quantum Lakes Dr) when he could hear yelling coming from the parking lot of, which is located directly in front of his residence. Hubers stated that he went outside to his balcony, which overlooks the parking lot, and he observed [REDACTED] and Martinson sitting in a black sedan. Hubers advised that Martinson was screaming loudly and was throwing several objects outside of the car. Hubers stated that he observed Martinson striking [REDACTED] in the left side of his body, specifically his arm and torso. Hubers was asked if he ever observed [REDACTED] touch Martinson which he stated that he did not. Hubers provided a sworn taped statement captured on my BWC (2137-2140 hours).

Based on my above investigation I find probable cause to charge Kimberley Martinson with one count of Domestic Battery in accordance to F.S.S. 784.03.1A1. Martinson was placed into handcuffs (double locked and checked for spacing) and transported to BBPD booking for processing. Martinson was later TOT to PBCJ without incident


