argument Kimberly pushed him twice in the chest with both hands, while calling him a "pussy". Gregory stated he tried getting Kimberly to calm down and that's when she attempted to kick him in the genitals and attempted to strike him. Gregory stated he grabbed Kimberly by the hands in an effort to stop her from striking him, and then he proceeded to put his hands around Kimberly and guide her to the floor. Gregory stated that's when Kimberly grabbed his wrists and dug her nails into them. While on the ground Kimberly grabbed Gregory's shirt and boxers and was pulling on them. Gregory stated Kimberly then proceeded to throw a water bottle at his head and left the residence stating "I hope you have a heart attack and die".

Gregory stated he and Kimberly have three daughters Mia Fischer (7 years old), Molly Fischer (5 years old), and Emma Fischer (3 years old) who were home at the time, but did not witness the incident. Their daughters were in their bedrooms.

I observed a laceration to Gregory's right index finger and right wrist. Additionally, Gregory's shirt and boxers were ripped, thus corroborating his statement. Gregory agreed to have pictures taken which were entered into BRPD evidence. However, he refused to complete a sworn written statement as he did not want Kimberly to be arrested.

I then spoke to Kimberly who walked to Gregory's ex wife's house at 2805 NW 45th St. Kimberly's account of the events were very inconsistent, she corroborated she was arguing with her husband. However, she stated during the argument he grabbed her by the head and threw her on the ground and then proceeded to drag her by the hair on the ground. I then asked Kimberly how Gregory had the laceration to his hand in which she replied she must have done it when she was reaching for her phone that he took, which she failed to mention the first time. Kimberly then went on to state she never touched Gregory and that he battered her. Kimberly's story was constantly changing and there was no physical evidence to corroborate Gregory slamming her head on the floor and dragging her by the hair. Kimberly did have a minor laceration to her right wrist that would corroborate Gregory's statement that he grabbed her by the wrist in order to prevent her from striking him.

Based on my investigation I was able to develop probable cause for the crime of battery (domestic in nature). My investigation determined Kimberly actually and intentionally touched Gregory, against his will, contrary to Florida State Statute 784.03(1). Gregory's injuries were concurrent with his statements.

Kimberly was placed under arrest and transported to the Boca Raton Police Department for processing. Once processed he was transported to Palm Beach County Jail.
