Narrative:

On January 8, 2018 at approximately 1741 hours, I responded to 1031 North E Street, Lake Worth, Palm Beach County, Florida in reference to a domestic violence incident that occurred at ~~124~~ ¹²⁷ East Woolbright Road Boynton Beach, Florida 33435.

Upon arrival I made contact with PBSO Deputy D. Harrison (ID9140) who advised he responded to above residence in reference to a disturbance (Reference PBSO Incident #18-00023914) and made contact with W/M Johnny Benton Jr. and W/F Kirsten Harris. Harrison advised that during their investigation it was discovered that a domestic violence incident occurred in the Boynton Beach jurisdiction between the two parties. Harrison advised that Benton had injuries to his facial area in the form of scratch marks and bruises. Harrison also stated prior to my arrival, Harris stated that she did strike Benton due to the fact that he damaged her car. It was confirmed that Benton and Harris have been boyfriend and girlfriend for eight months and have resided at above address for six months.

I then made contact with Benton who had various cuts, scratches and bruising under his left eye. Benton did immediately state that a few injuries were from a prior car accident. Benton then stated in a sworn statement that he picked up Harris in her 2001 Black Impala bearing Florida tag Z28EFH from work at ~~425~~ ⁴²⁶ East Woolbright Road Boynton Beach, FL at approximately 1600 hours and upon leaving the parking lot area they engaged in a verbal argument. Benton stated the argument escalated as he traveled West on Woolbright Road onto I95 North. Benton then advised Harris began to strike him with closed fist and proceeded to scratch him in his face area. Benton stated he continued to drive North on I95 and stated he tried to get Harris to stop striking him and scratching him. Benton stated when they arrived to their residence they continued with loud arguing and that is when PBSO arrived.

I then made contact with Harris who had no visible marks, cuts, or bruising on her person. Harris then confirmed her relationship with Benton and stated she is six months pregnant with their child. Harris advised that Benton picked her up from job from work at ~~425~~ ⁴²⁶ East Woolbright Road Boynton Beach, FL at approximately 1600 hours and upon leaving the parking lot they engaged in a verbal altercation. Harris stated she did not physically strike Benton at any point. I advised Harris that she told Deputy Harrison that he confirmed that she did strike Benton due to him crashing her vehicle the evening prior. Harris then confirmed that she did strike Benton in the vehicle. I then observed a small discolored bruise on Harris' hand, she advised it was old and from a prior incident in the residence.

Based on the above investigation, coupled with the taped sworn written statement from the victim, and corroborating defendant statement and victim injuries, I find Probable Cause to charge Kirsten Lynne Harris with one count of Domestic Simple Battery in violation of F.S.S. 784.03 1 (1A1). Kristen was transported to Bethesda Hospital for medical clearance due to her pregnancy, then BBPD for booking and later transported to Palm Beach County Jail.

I took photographs of Benton's injuries. Photographs of Harris' previous injury were taken and placed into BBPD Evidence.

Harris signed an Exemption from Public Records form and was provided with a Victim's Rights and Remedies pamphlet. Exemption form was submitted into BBPD transmittal.

This incident was captured on my department issued body camera.
