Upon arrival I spoke with Brandon. Brandon explained that Kitzya is his sister in law and she currently resides with him in the above address. Brandon explained that inside the apartment is his girlfriend (W/F Arihana Barreto Rodriguez), Brandon's son (W/M/J Elijah Cardona, 05/07/2015) and Kitzya's 1 year old daughter, Karolina who is mentioned above (unknown father). It should be noted that everyone named above resides in the home as a family.

Brandon explained that the reason Kitzya called police is because she believes he hurt Karolina (Kitzya's daughter). Brandon explained that he came home and Kitzya began to question him regarding the bruises on Karolina. Brandon advised that he did not inflict harm on Karolina. He stated that Tuesday night, Elijah (Brandon's son) and Karolina were playing together. He stated that Elijah accidentally hit her face with a fire truck toy. He stated that he told Kitzya this information the night that it occurred and that is the only known bruise to him. Brandon explained during the argument Kitzya approached him and began punching him multiple times in the face. Once this occurred, Arihana separated both and Brandon went outside while Kitzya called police. It should be noted that I observed a fist size red mark on Brandon's left side of his face. I asked him about his face, and he explained that this occurred today from Kitzya punching him multiple times.

I then spoke with Kitzya who explained that the argument was about how the bruises on Karolina came about. Kitzya explained how she believes that Brandon hurt her daughter Karolina. Kitzya did not see Brandon ever hit Karolina however she suspected it because he was watching over Karolina and Elijah. It should be noted Elijah did not have any markings and was unable to speak with me due to his age. Kitzya explained that no one in the home has seen Brandon hit either child however she has a strong suspicion it is Brandon. I asked Kitzya to explain the argument further and how it became physical. Kitzya stated that she confronted Brandon and Brandon confronted back. She stated that Brandon used the top of his head to head butt her in the nose. It should be noted there did not appear to be any markings on her nose. She explained that after the head butt, she pushed him back and then proceeded to punch him in the face multiple times. She stated that Arihana separated them and it was no longer physical at this point. Kitzya stated she called police while Brandon went outside. It should be noted; Kitzya's left hand appeared to be swollen.

I then spoke with Arihana who also stated the argument was regarding the bruises on Karolina. She advised she did not see Brandon hurt any of the children. Arihana explained that during the argument, Kitzya approached Brandon and Brandon approached back. She stated that at one point their faces did touch however she was unsure if it was an intentional head butt. She was unable to describe how their faces touched. She stated that the next thing she recalls is Kitzya throwing multiple punches to Brandon's face. She stated she then separated both and police were called.

Based on my investigation, I placed W/F Kitzya Barreto Rodriguez under arrest for Domestic Simple Battery after she admitted to pushing the victim and then following it up with multiple punches to his face.

Statements from all parties were refused and Brandon refused photographs of his face injuries. Kitzya's swollen hand was photographed and Karolia's bruises were photographed. A domestic pamphlet was provided to Brandon. DCF was notified.
