On August 15th, 2017 at approximately 0130 hrs, I (D/S Estavien ID 27531) responded to Flanigan's Seafood Bar & Grill (2335 S State Road 7, Wellington, FL 33414) in reference to a Domestic Battery.

Upon arrival, I was met by Victoria Collins (w/f-adult) who stated that her boyfriend, Korbin Brekke (w/m-adult) beat her outside 1465 CHAPPAREL WAY, WELLINGTON, FL 33414. Victoria and Korbin have lived together for 6 months. Victoria further stated that the incident began when her and Korbin got into an argument over damage to his vehicle. The altercation escalated to the point where Victoria had to call her friend Ashleigh Weeden (w/f-adult) to come pick her up, so that she could get away from Korbin. When Ashleigh arrived to pick Victoria up, Victoria attempted to get into the vehicle and shut the door so that she could leave, however Korbin prevented her from leaving by holding the car door open. In an attempt to escape from Korbin, Victoria kicked Korbin so that he would let go of the car door. In response, Korbin smacked her in the face, at which point they both began fighting. After they stopped fighting, Victoria got into the car and tried to leave again. Korbin then began repeatedly kicking Ashleigh's car, causing damage to the passenger side door. Korbin then grabbed a garbage can, and threw it on to the hood of Ashleigh's car. At that point, Ashleigh and Victoria were able to drive off, and waited for responding Deputies at Flanigan's. I observed that Victoria had bruising to her face, arms, and leg. Victoria refused medical attention.

I then spoke to Ashleigh, who stated that she came to pick Victoria up after receiving a text message from her which said, "I'm going to get my ass beat". After Ashleigh arrived, Korbin began fighting with Victoria. He then damaged her car by kicking it, and throwing a garbage can on the hood. Ashleigh's car is a Black Hyundai Sonata Bearing NY tag AND4678. I observed several major dents to the passenger side door of the vehicle (estimated damage \$2,000), and scratches to the hood (estimated damage \$1,000).

Afterwards, I spoke with Korbin who stated that he got into an argument with Victoria, and that they fought in his driveway. I observed bruising to Korbin's lip, and minor bruising to his left eye.

Based on the aforementioned events, Korbin was arrested for Simple Battery (Domestic) pursuant to F.S.S. 784.03(1A1), and Criminal Mischief (\$1,000 and over) pursuant to F.S.S. 806.13(1b3). He was transported to Wellington Regional Hospital for Medical Clearance, and later transported to Palm Beach County Jail.
