
On the **11** day of **May**, **2018** at **02:28** (Specifically include facts constituting cause for arrest.)

On 05/11/2018 at approximately 0157 hours, I conducted a traffic stop on 500 E Palmetto Park Road. on a white, 2013 Kia Rio bearing Florida tag # 62ERF. The driver of the vehicle who later became known as W/F Rowan A. Bawks Mc Farlane via her Florida Driver License was driving westbound on Palmetto Park Road. I conducted a traffic stop on the vehicle because the driver was operating the vehicle without any lights on during the night and the vehicle tag light was inoperable. Additionally, Rowan Bawks Mc Farlane failed to put her left turn signal on prior to entering into the inside lane from the outside lane (failure to use turn signal).

Upon making contact with the vehicle, I immediately detected the odor of marijuana (through my training and experience) emitting from the vehicle. I explained to Bawks Mc Farlane why I conducted a traffic stop on the vehicle. It should be noted that there was another subject sitting in the front, passenger side of the vehicle who later became known as Korbin H. Reynolds via his Florida Driver's License Card.

Officer Alvarez shortly arrived on scene to my incident location. I explained to both occupants that I detected the smell of marijuana (through my training and experience) emanating from the vehicle. I asked both occupants if they had been previously smoking or if they had any marijuana in the vehicle. I explained to both occupants that legally the vehicle would be searched as a result of the smell of marijuana. It should be noted that Bawks Mc Farlane stated that she had marijuana in her purse which was located in the back seat of the vehicle

I subsequently requested that both occupants exited the vehicle and Officer Alvarez conducted a search/pat down on white female Rowan A. Bawks Mc Farlane with negative results. Officer Mcquiston arrived on scene shortly thereafter and conducted a

search/pat down on Korbin Reynolds. It should be noted that Bawks Mc Farlane stated that he did not have any weapons on his person however did have a vape pen in his front right pocket . See his supplement for further.


Officer Alvarez ran both subjects through BRPD dispatch FCIC/NCIC and both of their identities were verified via their Florida Driver`s License Card. Officer Alvarez then proceeded to read Reynolds and Bawks Mc Farlane their Constitutional Warnings from an agency issued Miranda Card and they both stated that they understood their rights, understood what they meant, and would speak to officers without an attorney present.

I then searched the vehicle. I located a beige "Badgley Mischka" satchel underneath the front passenger side floorboard. Inside of the beige satchel, I located a clear Ziploc baggie which contained a green-leafy substance of what appeared to be marijuana (through my training and experience). I also located a tan in colored purse which also contained a green-leafy substance of what appeared to be marijuana (through my training and experience), a silver grinder with marijuana reside, rolling paper, a purple glass pipe with marijuana residue, and a yellow glass pipe with marijuana residue. The above mention items were located in the back seat of the vehicle. Additionally, I located a black vape pen which contained an attached vile of an unknown fluid like substance on top of the passenger seat.

I spoke to both parties separately. Reynolds stated that the "Badgley Mischka" satchel containing marijuana which I located underneath the front passenger side floorboard did not belong to him and belonged to Bawks Mc Farlane. He stated that the vape pen which contained an attached vile of an unknown fluid like substance on top of the passenger seat did belong to him. He stated that he smokes marijuana recreationally and does not sell or distribute marijuana.

I then spoke to Bawks Mc Farlane and she stated that the marijuana Badgley Mischka" satchel containing marijuana which I located underneath the front passenger side floorboard did belong to her. She also stated that the tan in colored purse which contained a green-leafy substance of what appeared to be marijuana (through my training and experience), the silver grinder with marijuana reside, rolling paper, the purple glass pipe with marijuana residue, and the yellow glass pipe with marijuana residue belonged to her. She stated that the vape pen did not belong to her. She stated that he smokes marijuana recreationally and does not sell or distribute marijuana.

I tested the green-leafy substance with a Quick Check test kit (One Use Only). The field test was positive for THC by turning purple. Officer Alvarez tested the brown in colored fluid like substance inside the vile attached to the vape pen with a Quick Check test kit (One Use Only). The field test was positive for THC by turning purple.

Based on my investigation, I placed Rowan A. Bawks Mc Farlane under arrest at 0228 hours for possession of marijuana under 20 grams pursuant to F.S.S 893.13(6B) and possession of paraphernalia (silver grinder, rolling paper, yellow glass pipe, and purple glass pipe) pursuant to F.S.S 893.147(1). She was transported to BRPD booking facility for processing and released Own Recognizance from the lobby of the BRPD. She was issued a Notice to Appear (NTA) with a court date of 06/14/2018 at 0830 hours.

I issued Rowan A. Bawks Mc Farlane a warning citation for the above mentioned traffic violations.

The marijuana was placed on a digital scale, weighed at 12. 8 grams in total, and submitted into BRPD evidence.

Based on my investigation, I placed Korbin Reynolds under arrest at 0228 hours for possession of marijuana hash oil pursuant to F.S.S 893.13(6A) and possession of paraphernalia (black vape pen) pursuant to F.S.S 893.147(1).

The vape pen and hash oil inside of the glass vile was placed on a digital scale, weighed at 10.6 grams in total, and submitted into BRPD evidence.
