<p>On 2/13/2017 at 1916 hours, I responded to the Quality Inn located at 2899 Federal Hwy. in reference to a female causing a disturbance in the hotel lobby.</p> <p>Upon my arrival, I made contact with an intoxicated white female, later identified by her FL ID as Kris Summas, who was sobbing on the couch in the lobby. She was screaming about not being able to get a key to a room. Her face was red and flushed, her eyes were blood shot and glossy. Summas smelled of an unidentified alcoholic beverage. I met with the Quality Inn Night Clerk John Ronzani who advised Summas is not a registered guest at the hotel and she was attempting to get a room key to a room. Ronzani was not able to provide her a key because she was not registered here. Summas refused to leave and continued to make a disturbance while lying on the lobby couch. In my presence, Ronzani issued Summas a verbal trespass warning from the property and advised she was not allowed on the property any longer due to her recent behavior.</p> <p>I attempted to reason with Summas, but she refused to leave. She remained seated on the lobby couch and said "fuck you" to me. I explained to Summas if she did not leave the property she would be arrested. Summas refused to leave and remained lying on the couch with her arms crossed. After multiple attempts to get her to leave, I then advised her she was under arrest and to stand up. She refused to stand up. I grabbed her left arm and Officer Bruggeman grabbed her right arm and we lifted her off the couch and I applied handcuffs. Based on my investigation, I placed Summas under arrest for trespass after arning, pursuant to FSS 810.09(1A).</p> <p>Officer Leinonen responded to complete a female search of Summas. After being placed into my patrol vehicle, Summas advised she had a preexisting clavicle injury and was transported to Boca ER for medical clearance. While being taken into the ER she made her body limp and dead weight and refused to walk, despite police's verbal commands to stand p. Because she refused to walk, Officer Bruggeman lifted her right side, and I</p>

<p>lifted her left side and placed her on an ER bed where she was medically cleared and released without incident.</p> <p>I then transported Summas back to the Boca Raton Police Temporary Holding Facility. While in the sally port, I gave Summas loud verbal commands to exit my patrol vehicle. Summas refused to exit. She actively pulled away from my attempts to remove her and leaned back away from the door. Officer Van Camp and Officer G. Desir arrived and she agreed to exit on her own, in lieu of us physically removing her. Summas was additionally charged with resisting without violence pursuant to FSS 843.02 for refusing to stand up from the couch at the hotel to be handcuffed after she was commanded to stand up, for refusing to walk to the ER bed after we commanded her to, and for resisting my efforts to remove her from my patrol vehicle.</p> <p>I issued Summas a court date of 3/16/2017 at 0830 hours at the South County Courthouse. Summas refused to sign for her court date but a copy was left in her property. After booking, Summas was delivered to PBCJ.</p>
