D.U.I. PROBABLE CAUSE AFFIDAVIT

ON THE 22 DAY OF September 2016 AT 0045 A.M P.M.

DEFENDANT: RAMNANAN, KRISHNA K.

PERSONAL CONTACT/DRIVING PATTERN/OBSERVATION OF DRIVER:

On the above date and time, while conducting stationary speed enforcement in the 1300 block of W. Boynton Beach Blvd, I received a rear antenna reading (Stalker Dual SL unit serial number DC111999, rear antenna serial number KC087855) of 70mph in a 40 mph speed zone. Let it be noted that this incident occurred within the City of Boynton Beach, Palm Beach County, Florida. I was parked on the center concrete median facing eastbound. As I received the reading, I looked at my passenger exterior mirror (window down) and observed the headlights of a vehicle in the inside lane approaching me quickly. The vehicle was the lead vehicle, with the closest vehicle behind it at approximately 50 yards. The reading of 70mph was consisted until the vehicle (2016 White Acura GVFG29) passed me, at which I received a reading of 45mph from the vehicles approaching me from the rear. I quickly switch to my front antenna (KC087885) and received a reading of 70mph from the Acura. Let it be noted that there was no vehicle traveling westbound to interfere with the 70mph reading from the Acura. Due to the speed of the vehicle I conducted a traffic stop on said vehicle at the 800 block of W. Boynton Beach Blvd.

I then made contact with the driver (later identified as Ramnanan, Krishna (10/18/80 via FL DL), identified myself and explained to him the reason for the traffic stop. Ramnanan advised that he understood and quickly apologized for his speed. Ramnanan continued to advise that he was on his way home from dinner, Carolina Ale House (local restaurant). While looking for his credentials, Ramnanan appeared to be confused. Ramnanan repeated the documents I requested of him (driver's license, vehicle registration and proof of vehicle insurance) numerous times to himself; and while doing so requested that I contacted a fellow officer that he knew numerous times. After approximately 5 minutes of waiting for the documents, Ramnanan was able to provide them. While speaking with Ramnanan I detected an odor of an alcoholic beverage emitting from his breath and persons, as well from within the vehicle. Ramnanan's eyes were bloodshot/glassy and his speech was thick and slurred. Due to Ramnanan appearance and the odor of the alcoholic beverage, I requested Ramnanan to exit his vehicle so that I could continue my investigation, which he agreed to. Once in front of my fully marked patrol vehicle (4445), I explained to Ramnanan why I requested that stepped out of his vehicle and that the investigation was being audio and video recorded, which he stated that he understood. I advised Ramnanan that I detected the odor of an alcoholic beverage emitting from his

breath and persons, which he advised that he had been drinking. Ramnanan advised that while at Carolina Ale House he had 3 draft beers. Ramnanan was very cooperative at this point of the investigation. Ramnanan continuous advised that he was just trying to get home and repeated his address to me numerous times. While speaking with Ramnanan, he would sway side to side/ forward and back. Based on my investigation at this point I requested Ramnanan to submit to a series of Road Side Sobriety Task, which he agreed to. Let it be noted that prior to starting the exercises I asked Ramnanan if he had any injuries and/or disabilities I should know of which at first he stated yes. Ramnanan advised that he has two screws on his right calve area from an injury in 1997. Ramnanan advised that he does not have any defects or disabilities from his injury. Ramnanan advised that he had no other injury or disability I should know about. See the following

WALK AND TURN:

The Task was explained and demonstrated to Ramnanan, which he stated that he understood. During the instruction stage, Ramnanan started the task too soon numerous times. There was a point that I felt that Ramnanan was going to fall over/injury himself while attempting to stand in the manner I requested of him, therefore I advised Ramnanan to stand a normal position. Ramnanan advised a difficult time understand the task and I had to demonstrate it numerous. While demonstrating it, Ramnanan advised that his "right leg is shorter than his left". When asked if he limp as a result, Ramnanan stated no. Ramnanan then advised that he has a documented diseased named "Vertical Turbulence". Ramnanan advised that his left eye sees further than his right due to the fact that his right eye is portioned higher in his face then his left eye. When I ask Ramnanan if he worn contacts for his "Vertical Turbulence" and if it effected his ability to operate a motor vehicle, he stated that he does not wear contacts and it did not affect his ability to operate a motor vehicle. Ramnanan then advised that his right foot is fatter than his left foot, due to numerous sprain/rowed ankles. I asked Ramnanan if there are any additional injuries and or defects I should know about, which he stated no. During the walking stage, Ramnanan took 9 steps forward, starting on the wrong foot. His turn was incorrect. On the returning 9 steps, he missed heel to toe between step number 3-4 and 4-5.

ONE LEG STAND:

The Task was explained and demonstrated to Ramnanan, which he stated that he understood. During the instructional stage, Ramnanan swayed side to side. When asked to stand with his feet together and arms to his side, Ramnanan advised that his too fat to have his feet together. At this point of the investigation Ramnanan started to become argumentative. Ramnanan started to the task too soon as times. During the balancing stage, Ramnanan raised his left

foot, dropped his foot on count 5, 14, 18 and finished his count of 27. Ramnanan skipped over number 11. Ramnanan arms were raised more than 6 inches from his side at times.

FINGER TO NOSE:

The Task was explained and demonstrated to Ramnanan, which he stated that he understood. During the instructional stage, Ramnanan swayed side to side. Ramnanan advised that he has document "ADHD". Ramnanan continued to be argumentative. During the exercise stage, Ramnanan failed to return his arm to his side after every command. Ramnanan missed the tip of his nose on his second "left" command and his third "right" command. On his third "right" command, Ramnanan began to drop his right arm and began to raise his left arm but corrected himself.

ROMBERG/ALPHABET:

The Task was explained and demonstrated to Ramnanan, which he stated that he understood. During the instructional stage, Ramnanan swayed side to side. Ramnanan continued to be argumentative. During the exercise stage, on his first attempt of having his eyes were close and his head was tilted back, I moved my position. Due to the fact that Ramnanan failed to have his eyes closed, he quickly fully opened his eyes and looked straight at me. I advised Ramnanan that he needed to keep his eyes closed and his head tilted back for the exercise, which he stated that he understood. Ramnanan was given a second chance on the task. Ramnanan recited the alphabet correctly.

Based on the above facts Ramnanan placed into custody under suspicion of DUI, which he stated that he understood. Ramnanan was placed into handcuff (D/L and Spaced) and placed in the back seat of my patrol vehicle (#4445). I then transported Ramnanan to the Boynton Beach Police Department to continue my investigation. I arrived at BBPD at 0144hrs, started my 20 minutes observation at 0145hrs and completed at 0205hrs. Upon completion I requested Ramnanan to provide a sample of his breath to determine the alcohol content, which he refused. I therefore read Ramnanan Implied Consent, which he advised that he did not understand. I then read Implied Consent two additional times, which Ramnanan advised that he still didn't understand. I asked Ramnanan, what part he didn't understand, which he stated "all of it". I then asked Ramnanan if it would be easier if he read it, which he stated no. I asked Ramnanan if he wanted me to read it again, which he stated "no matter how many times you read it I'm not going to understand it". I advised Ramnanan that I would read it one more time, which he repeated "I'm still not going to understand it". Let it be noted that while Ramnanan is answering me his eyes were close. I advised Ramnanan that regardless if he understood it or not on the 4th attempted that I would continue with the investigation Ramnanan advised that I couldn't do that and that he would still not understand it, regardless if I read it again. I then read Implied Consent the 4th time; I asked Ramnanan if he understood which he stated no. At that point, due to Ramnanan being uncooperative and refusing to understand what is being read, I continued the investigation. I requested a second time for Ramnanan to provide a sample of his breath, which he stated no. I then began to read Ramnanan his Miranda Warnings, which again Ramnanan advised that he didn't understand.

After reading his Miranda Warnings 3 times, Ramnanan requested a lawyer. At that point I discontinued my investigation with Ramnanan.

Based on the above stated facts I have established Probable Cause to charge Ramnanan with 1M count of DUI pursuant with F.S.S. 316.193.1. Ramnanan was later TOT PBCJ. BAT Video was later placed into BBPD Evidence. Ramnanan's vehicle was removed from scene by his wife /co-owner.

Ramnanan was given a citation for his initial speed, 70 mph in a 40 mph zone.
