

PROBABLE CAUSE STATEMENT  
**I made contact with the driver who was sitting in the driver seat of the utility vehicle stopped ahead of D/S Ficarra's patrol car. She was later identified as Krissy Elizabeth Walker by her Florida driver license. She was crying softly which filled her eyes with water. Her eyes were also red. Her cheeks were flushed and her mouth was dry. I could smell a strong odor of an unknown alcoholic beverage emanating from the inside of the car. I saw a red bull inside the center console cup holder. I explained that I was assisting D/S Ficarra who had completed his crash investigation involving her vehicle. Moreover I told her I would be conducting a criminal investigation for DUI. I told her I had a suspicion that she had been drinking an unspecified amount of alcoholic beverages. She nodded her head in approval. I asked if she would consent to performing Standardized Field Sobriety Evaluations (SFSTs) for determining if she was impaired while operating a motor vehicle. She refused my request. I explained Taylor Warnings that informed her performing the SFSTs were voluntary and she did not have to comply. However if she did not comply I would only be left with the evidence before me {previously mentioned indicators} and the observation of D/S Ficarra which could be strong basis of her being placed under arrest for DUI. Afterward I asked if she understood the warnings. She acknowledged, but still refused to perform the SFSTs. I asked her to exit the vehicle and escorted her to the back of D/S Ficarra's patrol car. She was wearing blue jean pants and a black sweater type shirt. She wore brown boots with heels. As she stood I noticed she swayed slightly from side to side. I could now smell a strong odor of an unknown alcoholic beverage emanating from her breath. Based on my observations of personal indicators of impairment exhibited by the defendant, coupled with the D/S Ficarra's investigation of the crash and his observation personal indicators of impairment exhibited by the defendant, probable cause was established for DUI. I told the defendant she was being placed under lawful arrest for DUI. She was handcuffed, double locked and checked for tightness prior to being seated into the rear of my patrol car. While en route to the testing facility the defendant told me not to be alarmed as she removed the handcuffs from her wrists. Upon our arrival I placed her back in handcuffs and escorted her into the facility. I conducted a 20 minute observation period where she ingested nothing into her body orally or otherwise. She also did not regurgitate. During the observation period she was allowed to use the restroom. Afterward I escorted her into the testing room and asked if she would give breath samples for the purpose of determining her alcohol content. She refused. I read her implied consent in its entirety and asked if she understood the consent.**




