On the above stated date and time I was on routine patrol within the 6400 block of Melaleuca Lane Greenacres when I observed a black Chevrolet Equinox bearing Florida tag GMXV42. It was facing westbound in the median attempting to make a left hand turn. The windows on the vehicle had a very dark tint all the way around making it impossible to see inside.

As the vehicle turned into Crown Plaza on the southeast corner of Melaleuca Lane and S. Jog Rd. I activated my emergency lights and siren to conduct a traffic stop. The Chevrolet parked in a parking space but kept their windows up. I made contact with the occupants on the passenger side of the vehicle. I knocked on the window several times before they were rolled down. As soon as they were rolled down I immediately smelled the odor of raw unburnt marijuana.

I asked the occupants who appeared nervous for their licenses or identification cards. The passenger identified himself by Florida driver's license as Franklin Valentin. He was breathing heavy and was trembling. The driver did not have any form of identification but provided her name verbally as Kristen E. Cottull. Cottull made several movements towards her waistband and along the sides of her body. I was able to verify the name she gave to me through investigative means. I provided Palm Beach County Sheriff's dispatch with their information and received a reply back informing me that Cottull did not have a valid driver's license in any state and was in fact driving on a suspended Massachusetts driver's license.

I tested the darkness of the tints with a department issued tint meter and received a measurement of five percent (Laser Labs Inc. Model 1000, last certified on 08/2016; serial #31609096). Next I asked that both occupants exit the vehicle so a search of the car could be conducted based on the obvious smell of marijuana. As I explained this to Valentin he asked if it was for the marijuana and when I told him yes he pointed to a Country Crock container on the center console and told me the marijuana was inside of it. I retrieved the container and found raw marijuana inside of it. I informed Valentin he was under arrest for possession of marijuana less than twenty grams pursuant to FSS 893.13 (6b).

I continued to search the interior of the vehicle and moved to the driver side. In the handle pocket of the driver's door I located a small piece of what I suspected to be crack cocaine. I field tested the substance with a Sirchie Cobalt test kit which was positive for the presence of cocaine. I continued searching around the driver seat and found more suspected crack cocaine on the floorboard along the right side of the driver's seat. This substance is consistent in shape, texture and color with what I found in the driver's door. Based on my findings I arrested and charged Cottull with possession of cocaine pursuant to FSS 893.13(6a).
