On Thursday, February 08, 2018, at 5:08 a.m., I initiated a traffic stop on a silver, four door Hyundai bearing a FL tag 561WS H. The traffic stop was initiated on State Road 91 (Florida's Turnpike), mile marker 94, in the northbound parking lot of the Lake Worth Service Plaza, in Palm Beach County.

I have spoken to the defendant minutes earlier due to a complaint that the defendant was allegedly following a vehicle to the aforementioned plaza. I met with the complainant at the Lake Worth Service Plaza Shell gas station and he pointed out to the defendant and the defendant's vehicle as the perpetrator. At the time, it appears that the defendant was leaning against her left rear passenger's door. Sergeant Henry CiChoski arrived on scene and indicated that he was going to the defendant's location. After I have spoken to the complainant, I proceeded to the defendant's location and found her sitting in her vehicle, while Sergeant CiChoski was moving away from the defendant's vehicle.

As I approached the defendant's vehicle, I smell a strong odor of an unknown alcoholic beverage coming from within the vehicle. Once I was close to the defendant, I noticed that the defendant appeared to have been impaired. The defendant's

I checked in the vehicle and noticed that the keys were not in the ignition or on the seat of the vehicle. The vehicle keys were not visible. I asked the defendant if she would like me to contact a relative or friend to pick her and her vehicle up and she said no. Sergeant CiChoski then asked her, how was she going to go home, and she said that she was not going anywhere. She stated that she was going to remain in the parking lot. I then asked her if she would like me to close her door and she said, "yes." Once I closed the door, I advised Sergeant CiChoski that I was going to observe the defendant from a distance to see if she attempts to drive away. Sergeant CiChoski and I then departed the scene. I drove just north of where the defendant was parked and observed the defendant. The defendant walked away from her vehicle and into the service plaza. A couple minutes later, she enter her vehicle, started the vehicle, shifted the gear in reverse and then drove rearward. I then activated my emergency lights, proceeded towards the vehicle and approached the defendants vehicle when the vehicle was moving forward. The defendant then stopped her vehicle. She then exited her vehicle, walked towards the curb, and sat down on the curb. The defendant handed me her driver's license and at the same time was attempting to make a phone call. I asked the defendant that I am going to be conducting DUI investigations and asked her if she was willing to perform Field Sobriety Task and at first, she refused but then complied. I had asked her if she had any physical conditions that would impede her from performing a field sobriety task, and she said no.

HGN - I asked her if she wears contact lenses or glasses she said no. Her eyes appears to be hazel, white and glassy. I advised her how to perform the task and she failed to perform the task. I then began explaining to the defendant how to perform the One Leg Stand. As I was explaining it to her she then stated that she refused to continue to perform the Field Sobriety Task. I then advised the defendant, at 5:12 a.m., that I was placing her under arrest. I cuffed the defendant and then I placed her in my patrol car. I had the Lake Worth Regional Communications Center (LWRCC) to contact the Palm Beach County Sherriff's Office and see if they had a female deputy, working that she may checked the defendant for any contraband or weapons upon her person.

Deputy Jodi Walker, ID: 28280 responded to the scene, pat search the defendant then placed her in my patrol car. I asked her if she would kindly transport the defendant to the Palm Beach County Correction Facility and she complied. Upon arrival to the Correction Facility, I observed the defendant for 20 minutes and the defendant did not place anything in her mouth or regurgitated. The defendant refused to provide a breath sample. The defendant was subsequently place in a holding cell until my paper work was completed. The defendant was booked into the Palm Beach County Jail for Driving under the Influence.
