

On 4-30-17 I responded to [REDACTED]

Upon arrival I made contact with [REDACTED] who was inside of the residence bleeding from his arm waiting for us to arrive and to stay away from Kristen Valentine. [REDACTED] explained to me that he had gone out to dinner with Valentine [REDACTED] and they both had a few drinks and when they came home valentine started to argue with him. [REDACTED] then said after she was yelling at him she left the house and walked over to the bar Pirates well located at 9477 FL A1AAIt, Lake Park, FL 33403 where he stated she drank until he got a phone call to go pick her up. [REDACTED] explained that Valentine was extremely drunk and started to punch him in the face and mouth area several times with a closed fist. [REDACTED] then said after she was punching him she went and grabbed a glass vase from the night stand and proceeded to throw it at him. [REDACTED] said he ducked to block the vase and it struck him in the arm and broke into several pieces and cut his arm open. [REDACTED] said that after his arm was cut he started to bleed all over the house and try and get away from Valentine and at that time Valentine left the residence and was no longer around the house.

At the house I observed [REDACTED] to have multiply raised red areas from where he was hit and he had a cut on his left arm from the vase. Inside the residence there was blood all over every room in the residence. [REDACTED] refused to cooperate any further after I took the first few pictures and said he really didn't want all this to happen.

With the above information I find probable cause to charge Kristen Valentine with Aggravated battery to cause great bodily harm FSS 784.045(1)(a)(1) and simple battery FSS 784.03(1)(a)(1).
