On Saturday, 03-24-18, I was on patrol in the Village of Royal Palm Beach, Palm Beach County. I was driving a marked PBSO patrol car and wearing my issued PBSO uniform. Around 1139 hours Deputy Bober (8292) responded to a call at 11111 Southern Blvd, Royal Palm Beach, Bru's Room. An employee, had called because we was very concerned about another employee, Kristen Monteverde. He said she appeared to be impaired when she arrived to work. He attempted to reason with her to prevent her from driving her car away. He didn't do anything to physically restrain her. He said she backed up her car and almost hit the building. Then she went and parked where she was when Deputy Bober arrived.

Deputy Bober made contact with Monteverde. She was sitting behind the wheel in the driver seat of a white SUV Toyota, tag #Z58FLC. The vehicle was registered to Monteverde. He identified her by her FL DL. He told me that upon contact with her, the vehicle engine was on, she was in the driver seat, and there was the strong odor of an unknown alcoholic beverage coming from her person. She was also slurring her speech.

When I arrived Monteverde was still in the driver seat but the vehicle engine was off. The door was open. I walked over to her to introduce myself. I could immediately smell a strong odor of an unknown alcoholic beverage, her speech was slurred, and her eyes were red and glassy. I only asked her how she was doing and she told me she had been drinking and didn't want to go to jail.

I then spoke to the employee who called the police. I then spoke to Deputy Bober about everything he had done when he arrived. I decided it was best to read miranda warnings to her. The interview was recorded on my patrol car video. I read miranda warnings to her and she stated she understood.

She admitted that she had been drinking last night. She said she had been drinking from a bottle of vodka. She wasn't really sure how much she had drank or when she stopped. She said she started drinking some time after midnight and had not slept.

She was unsteady on her feet while she was talking to me. She consented to perform voluntary road side tasks.

She performed the walk and turn task. She was unable to remain in the instructional position. She took the wrong number of steps walking down the line. She stepped off of the line several times. She missed stepping heel-to-toe by more than 1/2 inch. She did not turn in the manner I instructed. She then just stopped. She said she can't do it. She refused to attempt to complete the task.

She performed the one-leg stand task. She was unable to maintain her balance. She placed her foot down several times. She was using her arms for balance.

She performed the Finger to nose task. She was unable to touch the tip of her finger to the tip of her nose as instructed and demonstrated. She missed touching her the tip of her nose each time.

She performed the rhomberg with recitation. She chose to count numbers instead of saying the alphabet. I told her she would start on the number 63 and countdown to the number 31. She said she understood. She was unable to count down from 63 to 31. She repeated numbers many times. She would randomly start over. She kept opening her eyes. She had to use her arms to maintain her balance.

Monteverde told me that she had not hit her head on anything and had not been in a traffic accident. She said she was not diabetic or have epilepsy. She said she had not been to the doctor or dentist. She does not wear contacts.

At this time there is probable cause that Kristin A Monteverde did intentionally and knowingly commit the misdemeanor traffic offense of DUI, actual physical control of the vehicle, per FSS 316.193(1).

I then verified that the Toyota SUV was operational. I turned it on using the keys. The vehicle was able to drive in reverse and forward again.

I then transported her to the PBC jail BAT facility. I conducted a 20 minute observation. She did not place anything in her mouth or regurgitate. She consented to proved a lawful sample of her breath. The results were 0.338 BAC and 0.321 BAC. I then read miranda warnings to her. She stated she was going to refuse to answer all questions.




