

 R had another video of John attacking him. In the video you can see John standing by the front door with
 A Williams and can hear Lee stating that John attacked him. John can be seen using a black flip cellphone. John
 R then walks into the kitchen and is seen walking up and striking Lee in the face and Lee attempting to avoid
 A being struck. Then, the video ends. When asked about the video John stated that she was attempting to grab her
 R white cellphone from Lee.

Based on my above investigation and observations Kristina Sophie John was the primary physical aggressor and
 did actually and intentionally touch or strike Donny Lee against his will, contrary to Florida Statute
 784.03(1).
