
walking with her five year old daughter, [REDACTED]). John had some minor red markings on her right arm, but no other obvious, visible physical injuries.

I then made contact with Lee in the apartment. Lee stated that he and John were in an argument and that John was yelling at him in the kitchen and threatened him with a kitchen knife. Lee also stated that he captured the video on his cellphone. Lee unlocked his phone and verbally gave permission to view the video. The video showed Lee slamming the sliding glass door to the balcony and locking the door with John outside. When asked why he did this, Lee stated that he locked her outside because she was attacking him. Lee then stated that he had another video of John attacking him. In the video you can see John standing by the front door with Williams and can hear Lee stating that John attacked him. John can be seen using a black flip cellphone. John then walks into the kitchen and is seen walking up and striking Lee in the face and Lee attempting to avoid being struck. Then, the video ends. When asked about the video John stated that she was attempting to grab her white cellphone from Lee.

Based on my above investigation and observations Kristina Sophie John was the primary physical aggressor and did actually and intentionally touch or strike Donny Lee against his will, contrary to Florida Statute 784.03 (1).
