According to dispatch operations, Umosella had her vehicle repossessed in the City Place district of West Palm Beach.</p> <p>I asked to speak with Umosella and invited her into my office. Already being forewarned that she was irrate by dispatch, I tried to be especially nice to her however she immediately began to tell me that in order for her car to be repoed, they needed to contact her first. I tried to explain to her that the process of getting her car back, Umosella directed her anger and rudeness towards me. After turning her anger towards me, Umosella began to curse and insult me. I ended my assitance and told Umosella that I was done talking to her and told her she could leave.</p> <p>While escorting her out, more insults were shouted and and I explained to her that this was not our fault. She told me as we got to the front door that I'm lucky if she didn't beat my ass. As we approached the stairs, Umosella turned back towards me and spit on me. I grabbed her by the neck and escorted her to the ground. While on the ground, she tried to kick me in the groin, however I was able to move and take a kick to the right leg. It should be noted that Umosella was wearing cowboy boots with a heel. Umosella was quickly taken into custody and placed into department issued handcuffs according to department policy. She immediately began to apologize and refer to me as an officer. It should be noted, that I was dressed in full class B uniforms, complete with badge, name tag and City of West Palm Beach Police patches. It would have been impossible for Umosella to not recognize me as a uniformed officer.</p> <p>Based on the above facts, I charged Umosella with Battery of Law Enforcement Officer as she unlawfully spat on my frontal uniform and kicked my right thigh area of my leg, contrary to F.S.S. 784.07. Additionally, because of the kick during my attempt to bring Umosella into custody, I also feel probable cause exist to charge her with Resisting with Violence per F.S.S. 843.01.</p>
