

I, D/S Grimaldi #24094, responded [REDACTED], FL to assist The Department of Children and Families (DCF) with a motion to compel as ordered by the Honorable Dallah Weiss, 15th Judicial Circuit Court.

The defendants are admitted heroin users and have an open DCF case. DCF was concerned for the welfare of the 3 year old minor child [REDACTED]. DCF has made several numerous attempts to enter the home to check the welfare of the child but has been refused access by all 3 defendants. All 3 defendants live in the household together [REDACTED]. Defendants Jeffrey Hanna and Kristine Schreckengost admitted they are long time drug user who have spent the last 3 weeks helping each other try to stop using drugs without the assistance of any programs. Jeffrey Hanna and Kristine Schreckengost further told DCF Investigator that they openly use drugs in the household.

Upon entering the home I observed what I suspected from my training and experience to be drug paraphernalia. There was an open garbage bag containing small clear plastic baggies with white powder residue and straws with white powder residue. The bag was hanging from the handle of a bi fold door in the hallway well within reach of the 3 year old victim. When asked by DCF about the bag Defendant Schreckengost admitted that she was "cleaning up" the house and that the baggies were old heroin bags she was throwing away.

On the floor near the bed of the front bedroom was a tin container also containing numerous small clear plastic baggies suspected to contain heroin residue. The victim child [REDACTED] his toys were also in the bedroom. The tin container was kept next to the victim's toy dump truck. In the bathroom used by defendants Jeffrey Hanna and Kristine Schreckengost there were straws containing white powder substance and credit cards in the name of the defendants containing white powder substance as well as what is commonly known as a "grinder". All of these items are suspected drug paraphernalia known to be used when cutting and snorting heroin.

Attached to the master bedroom where Defendant Kay Hanna sleeps is a master bathroom. In the bathroom I observed numerous tub toys and small plastic container containing empty small clear plastic baggies and cut straws with white powder on the ends. It should also be noted that there was various toys belonging to the victim inside Kay's bedroom. Defendant Kay Hanna advised that she cuts her percocet up because she can't swallow the pills. Kay Hanna admitted that the victim [REDACTED] has access to her room and spends much time there.



Schreckengost agreed to take a field urine test which tested positive for cocaine, opioids and oxycodone.
