On the 23 day of September, 2019 at 03:26 (Specifically include facts constituting cause for arrest.)

The following incident occurred in the City of Delray Beach, Palm Beach County, Florida:

On the above date and time while on routine patrol, I observed a white Mercedes bearing FL tag #GIQ111 backed into the dark parking lot across from the Sundry house which is closed at this time. The vehicle had its headlights on and was running. As I began pulling into the parking lot, the driver turned off all the lights. I observed a W/F in the driver's seat and a W/M in the front passenger seat of the vehicle. I then approached the vehicle and made contact with the driver, Krystal Jaworski, and passenger, David Richards. In plain view, I saw an open Hurricane beer can sitting in the center cup holder. When I asked Jaworski if the vehicle was registered to her, she stated that it was not her car and that it belonged to a W/M who she only knew as "David" that met earlier. Ofc. Reed read Jaworski her Miranda warnings which she acknowledged and waived. Post Miranda, Jaworski stated that she met "David" in Boynton on Saturday and they ubered to Bostons on the Beach. According to Jaworski, he allegedly handed her a set of keys which contained the Mercedes car key fob and said to hold them. Later in the night, they argued and he broke her phone and left. Jaworski stated that she then walked around downtown trying the alarm on the key fob to locate the vehicle. She stated that she located the vehicle parked inside of the fenced in parking garage for SOFA Apartments located at 150 SE 2nd Ave. Jaworski stated that she went to the closed gate and used a FOB that was on the keychain to gain access into the parking garage. She then entered the vehicle and drove it away. Jaworski advised that she took the car because he broke her phone and she knew that she should not have taken the car nor did she have permission. She stated that she just met Richards and picked him up to go look for "David".

Ofc. Salguero made contact with the registered owner of the vehicle, Max Puder who resides at 150 SE 2nd Ave. he advised that his vehicle should be parked inside of the garage and the last time that he saw it was on 9/22/19 at approximately 1800. Puder

Based on the above stated facts, there is probable cause to charge, Krystal Jaworski, with Grand Theft Auto \$20,000 or more pursuant to F.S.S. 812.014(2)(B).
