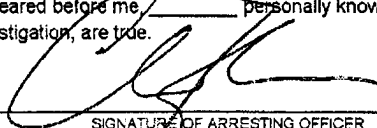

	At 2227 hours Officer Blanco and I arrived too the residence and could hear a loud disturbance inside with what appeared to be items being thrown or tossed about. Contact was made with Ksenija Kaminskaja W/F DOB 7/10/1988 and her boyfriend Peter Barabasha 7/7/1982 who have been in a relationship for over 1 year and reside together as a family in the apartment for 6 months. As we separated Ksenija and Peter from each other, I overheard Peter tell Officer Blanco he was punched in the face. Ksenija denied any physical altercation. Upon physically seeing Peter's face, I could see a red mark over the top of his right eye near his forehead which would be consistent with him being battered in the face or head area as he stated. Upon seeing Ksenija was being placed in handcuffs, he then denied he was battered and refused to have pictures taken or repeat his original statement of being battered. This statement was captured on Officer Blanco's Body Worn Camera. Based on the above information, Probable cause exist to arrest and charge Ksenija Kaminskaja W/F DOB 7/10/1988 with Domestic Battery in violation of FSS. 784.03(1A1). Ksenija was placed in handcuffs which were doubled locked and checked for proper fit. Ksenija was later transported and booked into the county jail without incident. My BWC was active during this incident and later uploaded to evidence.com.
