<p>On Tuesday, August 23, 2016 at 0117 hours, I was conducting routine patrol operations in a fully marked Jupiter Police Department (JPD) police vehicle, #1605, and wearing full police uniform in the area of W Indiantown Rd and Island Way when I observed a grey Dodge Charger bearing Florida tag 365YRR traveling eastbound with what appeared to be dark window tint, in violation of FSS 316.2953. I positioned my patrol vehicle behind the Charger and initiated a traffic stop by activating my overhead emergency lighting system and siren in the area of Island Way and Limestone Creek Rd. The vehicle then accelerated at a high rate of speed in a northbound direction on Limestone Creek Rd.</p>									
<p>I followed the vehicle as it traveled eastbound onto Church St, where I observed the vehicle turn off its headlights, "black out", in an attempt to not be seen. The vehicle came to a stop in front of 6642 Church St, where the occupants exited the vehicle and fled on foot toward the residence. This is commonly referred to as a "bail out", where the occupants are actively trying to evade police contact and therefore obstructing any further investigation.</p>									
<p>I observed the driver, a white female wearing a sleeveless black top and shorts, exit the driver's door and run behind the vehicle heading southbound toward the aforementioned home address. When I pulled up to the vehicle, I oriented my spotlight toward the home and observed a white female wearing a sleeveless top and shorts attempting to jump a wooden fence that leads to the back of the residence. I immediately recognized the female as W/F Kyla St Mary 10/27/1990 from a previous encounter. I gave St Mary a verbal command to discontinue her attempts to climb the fence, to which she initially appeared to ignore but ultimately complied with my verbal commands. St Mary was placed into custody, handcuffed behind her back with the handcuffs being double locked and checked for proper spacing.</p>									
<p>A search of the vehicle yielded 14 grams of a white rock like substance on the driver's</p>

floorboard of the vehicle. The substance was fielded tested positive as cocaine using a "Nik Cocaine Wipe".

Due to the above described articulated circumstances, I found probable cause to charge W/F Kyla St Mary 10/27/1990 with the following:

Fleeing or Attempting to Elude a Marked Police Car, as St Mary did willfully flee or attempt to elude a law enforcement officer in an authorized law enforcement patrol vehicle with agency insignia and other jurisdictional markings prominently displayed on the vehicle with siren and lights activated, contrary to Florida State Statute 316.1935(2), a 3rd Degree Felony.

Possession of Cocaine, as St Mary was unlawfully and knowingly in actual or constructive possession of cocaine, a controlled substance, contrary to Florida State Statute 893.13, a 3rd Degree Felony.
