The complainant informed communications that a white ford van bearing tag# Y35GRR was driving west onto Orange Blvd. The complainant then updated communications that the van was now, driving back east onto Orange Blvd.

While in the 15000 block of Orange Blvd, driving west bound, I observed a White in color van with a passenger side headlight out. As I then turned around I observed a Red Dodge Durango behind the vehicle with its emergency flashers activated. The vehicle stopped to allow me to complete my turn. Communications then informed me that a red Dodge Durango was behind the reported drunk driver. As I caught up to the vehicle passing Grapeview Blvd now heading east bound on Orange Ave. I was able to pace the vehicle at 55 mph. I also noticed the tag light on the van not working. While approaching the four way intersection of 140th Ave and Orange Blvd, the vehicle turned on its left signal and then made a left turn from the far right lane not utilizing the left turn lane. I then active my red and blue lights to conduct a traffic stop for the violations. This vehicle beared a Florida tag of Y35GRR.

While my red and blue were activated, the van continuously braked while driving and continued driving partially in the grassy swale area then back onto the road way. The vehicle continued driving then stopped partially on the roadway and swale in the 7200 block of 140th Ave North. Upon contact with the driver, I identified myself and told him the reason for the stop.


