On the **8** day of **April**, **2017** at **22:47** (Specifically include facts constituting cause for arrest.)

On 04/11/17, at 1357hrs, I was dispatched to the Police Department's lobby, located at 210 Military Trail, Jupiter, in reference to a supplement investigation for a case that occurred on 04/08/17. Upon arrival I met with the victim, Natasha Davis (w/f 08/04/76). Natasha advised two days ago, she was battered by a male she was dating but, at the time, declined prosecution. Natasha was now requesting to press charges. I pulled up the case information and read the following report by Jupiter Police Officer, Sean Pope:

\*\*\*\*\*

"On 04/08/17 I responded to the LaQuinta located at 34 Fisherman's Way in reference to a delayed (30 minutes) assault complaint. Upon arrival, I met with the victim Natasha Davis 08/04/76 in room 206. Davis advised the following;

Davis was staying at the hotel with a male subject she identified as Kyle Jacobus 08/21/83. Davis stated that she has been casually dating Jacobus since October. Jacobus resides in Orlando, and Davis resides in the Town of Jupiter. Occasionally Davis meets Jacobus in local hotels and stays with Jacobus for a night or two. Davis stated that Jacobus does landscaping work, and sometimes comes to this area for work and stays at local hotels during this time. Davis has never allowed Jacobus to stay her residence. Davis further advised that they have never resided together and do not have any children in common.

On this date, Davis and Jacobus were consuming alcohol at the beach and in the hotel room. While in the hotel room, and argument ensued between both subjects. During the argument, Davis alleged that it turned physical, and that Jacobus punched her on top of her head causing an abrasion that was bleeding. Davis also advised that she was sitting on the floor, and Jacobus kicked her a couple of times. Jacobus appeared very angry, grabbed Davis' purse and left the room. Jacobus left the area prior to arrival in his

personal vehicle. Davis believes that Jacobus was enroute back to Orlando. Davis stated that her purse contained her cell phone, car keys and credit cards.

Davis stated she would not have called the police, and would have just left the hotel if she had her car keys. Davis also advised that she did not want to cooperate with criminal prosecution of Jacobus.

I observed the injury to Davis` head, which appeared to be a small abrasion/laceration on her scalp that was bloody. Blood stains were also present on the bed pillows and on the wall next to the bed. Davis` hair was also saturated with blood. I also observed a bloody towel, and blood stains on the sink counter top where Davis attempted to clean her wound. Davis declined medical attention on scene.

After speaking further to Davis, she was encouraged to cooperate with criminal prosecution. Davis agreed to provide a written statement, but continued to decline prosecution. Davis stated "If I prosecute, I`m doing all the work". I attempted to collect Jacobus` personal information from Davis. Davis stated she was unsure of Jacobus` date of birth, residential address or work location. Jacobus` information and address was located via DAVID for the purpose of this report.


Davis was advised of the process for declining prosecution, and Davis voluntarily signed a waiver of prosecution."

Natasha explained that she originally believed her purse was taken the night of the incident by Kyle, but she subsequently located it mixed in her belongings after police left. What she didn`t advise to the officers on scene the night of the incident was that during the altercation, Kyle became jealous of Natasha. At that point he broke her iPhone 6s, valued at \$802.49, by smashing it multiple times on the corner of the desk. He also broke her Marc Jacob sunglasses valued at \$150. She later found these items in her purse (which she originally thought was stolen). She brought them into the Police Department and I witnessed the damage to both items. Natasha claimed she went to Jupiter Medical Center the day after the incident (04/10/17). There were no major injuries but she did sustain a laceration and concussion to her head from the battery.

Natasha wrote a sworn written statement and requested to rescind her original waiver of prosecution. Kyle lives in the Orlando area so charges will be filed with the state attorney office.

Based on the above, probable cause exists to charge Kyle Jacobus with Simple Battery, contrary to FSS 784.03(1) and (2) counts of Criminal Mischief, contrary to FSS 806.13(1) a.
