Narrative:

On 04-11-18, at approximately 1542 hours, I responded to 3617 High Ridge Way, # 307, Boynton Beach, Palm Beach County, in reference to a child abuse investigation, involving the Department of Children and Family Services (DCF).

Upon arrival, I met with the DCF case worker, Torres Holmes. Torres handed me a DCF Intake Report, # 2018-505309-01. The allegations stated that Kyriakos Antoniou was living with Mercia DaSilva. The allegations further stated that there is an Injunction for Protection Against Domestic Violence with Dasilva being the protected person. There was also a purported history of domestic violence.

Prior to making contact with with anyone at the residence, I conducted a search for the Injunction in FCIC/ NCIC. There was an active Injunction for Protection Against Domestic Violence, listing DaSilva as the Petitioner and Antoniou as the Respondent. This was in reference to Palm Beach County Court Case # 50-2017-DR-011192-XXXX-SB. The Injunction was valid until 04-14-18.

I then made contact with Dasilva and Antoniou at the residence.

According to Antoniou there is an Injunction for Protection Against Domestic Violence that is about to expire on 04-14-18. Antoiniou stated that DaSilva had moved in with him approximately 2-3 weeks ago and they are getting married next week. Antoniou stated that they already exchanged vows at the court house and Dasilva went there to have the Injunction for Protection Against Domestic Violence Order rescinded. Antoniou stated that since the Injunction for Protection Against Domestic Violence was going to expire soon Dasilva was advised to just let it expire, since the process would take a few days anyway.

DaSilva provided a substantially similar statement as Antoniou. DaSilva stated that she loves Antoniou and did not want him to go to jail. Dasilva did not obtain any documentation in regards to have the Injunction rescinded and did not know who she spoke with at the court house.

Based on the above information, I find probable cause to charge Antoniou with one count of Violation of an Injunction for Protection Against Domestic Violence, pursuant to F.S.S. 741.31. Antoniou was transported to the BBPD for processing and later turned over to the Palm Beach County Jail.

An Exemption from Public Records Disclosure Form was obtained from DaSilva. DaSilva was issued a Domestic Violence Brochure and Victim's Right Pamphlet.

This investigation was conducted utilizing a body worn camera.


