Michael advised he and his wife Lakshmi Brennen (DOB 3/11/1977) were inside the residence, and he was in the bedroom with his dog when he heard the other bedroom door inside the residence slam. Michael advised he then heard Lakshmi yelling and screaming at their 7-month-old son Cody Brennen. Michael stated he walked into the living room and Lakshmi was in Cody's face yelling and screaming because he wouldn't eat his food.

At this point in time, Michael then stated he told Lakshmi to stop yelling at Cody and afterwards made a comment that Lakshmi is just like her crazy mother, later identified to be Krystyna Orkisz (DOB 3/16/1953). Michael then stated Lakshmi grabbed the tray from the baby's highchair, in which Cody was sitting, and placed it over her head as if she was going to hit him with it. Michael Stated he put his hands up because he was in fear she was going to hit him with the tray. Michael advised Lakshmi then turned and continued to yell at Cody. Michael said he then grabbed Lakshmi in an attempt to protect Cody forcing them both to the floor. Michael stated that when they both were on the floor Lakshmi bit him on his right forearm causing him to strike her right side of her face with his left hand, to get Lakshmi to stop biting him. Michael said he left the residence to call 911 and waited in the parking lot for Palm Beach Gardens Police Officers to arrive.

PBG Officers made entry into the home after Michael stated he was in fear that Lakshmi was going to harm Cody. Upon entry, PBG Officers made contact with Lakshmi, and gave verbal orders for her to release Cody and give him to officers. Lakshmi refused to cooperate in releasing Cody. Upon this refusal Officer Eriksson ID 496 was forced to take Cody from her, and officers detained Lakshmi.

Upon securing the residence, I made contact with Lakshmi for her statement to tonight's events. Lakshmi advised she was feeding the Cody and started to yell and scream at Cody, when Cody refused to eat Lakshmi stated Michael became upset and grabbed her causing her to fall. Lakshmi then advised Michael punched her and in return, she bit his forearm. Lakshmi said Michael then put his hands around her neck and started strangling her. Lakshmi advises she never lost consciousness after the event.

I observed a bite mark on Michael's right forearm. Lakshmi sustained an contusion to her right side of her head from Michael striking her to break free. There were no signs of strangulation around Lakshmi's neck. Palm Beach Gardens Fire Rescue (Run#19009667) responded and treated Lakshmi's injuries. Lakshmi was transported to Palm Beach Gardens Medical Center for clearance. Michael refused treatment.

Lakshmi was placed under arrest at Palm Beach Gardens Medical Center for Battery F.S.S 784.03(1)(A)(1) and Simple Assault F.S.S 784.011 (Domestic) and transported to PBGPD for processing. Michael gave a sworn statement. A Victim Notification and a Victims Brochure was given to Michael. Department of Children and Families was contacted and Operator Rae ID 222 advised they are going to take the case. Lakshmi was transported to Palm Beach County Jail. Cody was given to Lakshmi's mother Krystyna for the evening.
