

On November 4th, 2016 at approximately 11:22 pm, I was dispatched to 13461 Treasure Cove Circle in unincorporated North Palm Beach, FL regarding a domestic dispute. The call notes stated that the complainant's husband squeezed her face.

Upon arrival, I met with the complainant who was identified as Wendy Day. Wendy stated that approximately 20 minutes ago, she and her husband Lance Day got into a verbal argument over a song that she was playing on her iPod. She stated that Lance then became upset and grabbed her face, squeezing it very hard. I did observe that the left side of Wendy's face had deep purple marks on it towards the top of her cheek and a small mark near her chin. The house was checked but he was not inside and Wendy stated she believed Lance took the dogs for a walk.

We then exited the house and noticed who Wendy pointed out as Lance walking two dogs walking towards the house. I spoke with Lance privately regarding this incident. I asked him what had happened this evening. He stated that he became upset about a song that Wendy was playing on her iPod. He then, without specifically being asked, stated that he grabbed her face with his hands and squeezed her cheeks. He acknowledged that the injuries on her face was caused by this. He did not state that Wendy became violent at all with him during this incident. I then placed him into PBSO issued handcuffs which were checked for proper fit and double locked.

Wendy became extremely upset that Lance was being arrested. She then asked me if I could release him to which I stated I could not due to this being domestic violence related. She refused to give a statement and refused to have pictures taken. She asked us if we could just use this as a scare tactic and let him go, to which again, I denied.

This case is cleared by arrest.
