On the **15** day of **December**, **2017** at **03:36** (Specifically include facts constituting cause for arrest.)

On 12/15/2017, while patrolling the parking lot of 21230 St Andrews Blvd, I observed a black 2015 Dodge bearing Fl tag#BXUG15 parked in a parking spot with the lights on and the car still running. The Dodge appeared to be occupied by at least two people. As I approached the vehicle I saw that it was occupied and then I turned my flashlight on and shined it into the window. The driver appeared to drop something between his legs and started dusting his pants. I then made contact with three subjects, driver Ray Desamour, front passenger Laura Brandt and back seat passenger Joshua Fine. I then asked them what they were doing in the parking lot and they advised they were waiting on a friend. While speaking to Desamour I could see white powder on his pants and I also observed a baggie with white powdery substance in plain view on the driver side floorboard, which appeared to be cocaine. Ofc Gannon arrived on scene as my backup followed by Ofc Alvarez and Ofc Codling T.

Based on plain view I had all subjects exit the vehicle. I then searched Desamour and Fine and nothing suspicious was noted. Ofc Alvarez searched Brandt and nothing suspicious was noted. I then retrieved the baggie, field tested the cocaine with a Quick Check Cocaine test kit (one use only) and it tested positive for cocaine by turning light blue. I then searched the vehicle and located another bag with cocaine inside on the center console area. The cocaine inside was also field tested and was positive for cocaine. Ofc Gannon read all three subjects their Constitutional Warnings in the presence of Ofc Alvarez.

I then spoke to Laura Brandt and she advised that the three of them were partaking in the cocaine. She stated that the cocaine came from Desamour but she didn't want to get him in trouble. Brandt advised that they used a key to ingest the cocaine. Brandt advised that was the reason they pulled into the parking spot so they could do a line of the cocaine. Brandt stated that they used Desamour's car key to scoop the cocaine out of the bag to ingest it.

I then spoke to Ray Desamour and he advised that he had no idea who the cocaine belonged too. He advised the car belonged to his momma and was not sure if she might have left the cocaine in the car or if she had anyone in the car that might have dropped the cocaine. Desamour stated that he was unaware how that cocaine got on the floorboard of the car and fell in between his feet. Desamour stated that the cocaine belonged to no one in the car.

I then spoke with Joshua Fine and he advised that he was on his cell phone texting and at one point he was trying to console Brandt. Fine claimed he had no idea that there was cocaine in the car and he was unaware of anyone using any illegal substances.

Based on the above information I placed Brandt and Desamour into custody for possession cocaine and paraphernalia. I then transported both subjects to BRPD to be processed. The cocaine was weighed for a total weight of .4grams (both baggies). Brandt and Desamour are being charged under F.S.S 893.13(6a) for possession of cocaine and they are also being charged under F.S.S 893.147(1b) for possession of paraphernalia. They were processed at BRPD and then transported to Palm Beach County jail for final disposition. The car was towed to West Way and Fine left without further incident.
