On the 17 day of March, 2018 at 23:40 (Specifically include facts constituting cause for arrest.)

On 03/17/18 at approximately 2018 hours, I responded to the area of 328 NE 42nd Street in reference to a DUI investigation. Ivaldo Sebastianelli called 9-1-1 after he observed a white Acura (FL tag BAFE87) swerving into the northbound lane while driving southbound on Dixie Highway. The vehicle eventually went back into the southbound lanes and continued passing Yamato Road swerving in between lanes.

Officer Tyson observed the Acura in the area of 4200 North Dixie Highway, and he noticed that the vehicle did not have its headlights on at night. Officer Tyson initiated a traffic stop on the Acura at which he advised didn't stop after several blares from his siren. The vehicle finally stopped in the area of 328 NE 42nd Street.

Upon arrival, I observed the driver who was later identified as Laura Odey. I observed Odey as the sole occupant of the vehicle. It should be noted that I was able to smell an odor of an alcoholic beverage coming from her breath. Her eyes were glassy. Odey advised that she was coming from Publix and was headed towards her home at 5280 NW 2nd Avenue in Boca Raton. Odey thought she was driving southbound on NW 2nd Avenue when in actuality she was on Dixie Hwy. Odey advised she was going to continue southbound; however, her home was north of our location.

I informed Odey that based on the observations of Sebastianelli, Officer Tyson and myself I suspected her to be under the influence of alcohol and that I wanted her to perform field sobriety tasks to dispel my alarm. Odey refused to perform the tasks. I explained to Odey that the tasks were voluntary, but if she refused, it could be used against her in a court of law. Odey again refused to perform the tasks.

Based on my observations and investigation, I developed probable cause to charge Odey with Driving Under the Influence pursuant F.S.S. 316.193(1). I then opened Odey's driver side door and gave her a lawful order to exit the vehicle. Odey then reached inside of

her purse that was on her lap. In fear that Odey could have possibly have been reaching for a weapon, I immediately grabbed Odey's left arm and pulled her up so she could get out of the vehicle. Odey continued to brace and pull away from officers as she was being placed into handcuffs. With the help of Officer Tyson, Officer Prewitt and Officer Codling I was able to place Odey into handcuffs and to the back of my patrol vehicle. While in my patrol car (Unit#158) Odey was able to free one of her hands from the handcuffs. Odey continued to become belligerent and uncooperative with officers. Odey was then taken out of the vehicle and continued to brace and pull away from officers. Odey was again placed into handcuffs with the help of Officer Coon, Officer Tyson, Officer Prewitt, and myself.

Odey's vehicle was towed by Emerald towing. Odey was then transported to Boca Raton Police Department's temporary holding facility for further processing.

Officer Genden conducted the Intoxilyzer 8000 testing. I asked Odey to provide a breath sample and she said "yes". However, she refused to blow into the machine. Officer Genden noted that she did not wrap her lips around the entire tube and did not blow air out. Officer Genden provided Odey with several opportunities to blow into the machine but she did not. I asked Odey again if she was willing to provide a breath sample and she refused to speak to me.

Due to Odey continuously bracing, pulling and not complying with officers order she is being additionally charged with resisting without violence pursuant Florida Statute 843.02. She was given the court date of 04/09/2018 at 08:30 am. After processing, she was transported to the Palm Beach County Jail.
