SECONDS LATER, I OBSERVED AN UNKNOWN WHITE FEMALE, NOW KNOWN AS LAURALYN O. SALITO, EXIT THE DRIVER'S SIDE DOOR AND ENTER THE BUSINESS. I responded to the Chevron Gas Station, 11858 Forest Hill Blvd., located in the Village of Wellington in reference to an Unwanted Guest. I met with employee, Alexander Ramirez, who provided the following information in a sworn written and verbal statement. He was working the night shift when he went outside to smoke a cigarette. Laura and her boyfriend Gary an ex-employee approached me in a dark blue Corolla and started threatening me because I had caught them stealing from the store before. That's why Gary was fired. Laura told him she was going to shoot him and drop him like a bag. He called the police and they left before the police arrived. Laura came back to the gas station alone, started threatening him again. Laura entered the store and began hitting him several times about the head and shoulder areas. This action was caught on the stores CCTV surveillance cameras. He went outside of the store and an police officer was there because of the 1st call reference Laura and Gary. I reviewed the Chevron's in store surveillance video of the incident which confirmed Laura Salito did fact hit Alex Ramirez with her hands against his will. Based on my investigation Laura Salito is charged with Battery pursuant to FSS 784.03 (1).

Prior to Laura's arrest for Battery, Laura was observed driving a blue Toyota Corolla by D/S J. Brown #8678 and Laura appeared to be under the influence of an unknown substance. DUI 10 investigator E. White #7209 was called to the scene, conducted roadside sobriety test and charged with Driving Under the Influence. I assisted Inv. White and D/S Brown in taking Laura into custody and placing her in the back of Inv. White's patrol vehicle to be transported to the PBC Main Detention Center
