

On 10-23-17, I responded to Publix (4849 S. Military Trail, Greenacres, FL 33463) in reference to a retail theft. I was advised that W/F, later identified by California ID, Lauren Ashley McCoy (DOB 10-3-85) was detained and cooperative.

Upon arrival I made contact with Loss Prevention Officer Menos. Menos advised that he observed McCoy enter the Dell section of the store. Once there she selected a Publix Reversible bag (valued at \$0.99), sushi: Chef Sampler (valued at \$12.49), a Spinach Quiche (valued at \$5.99), Frozen Food: PF Changs (valued at \$7.49), and a Salad: Bistro Santa Fe (valued at \$3.99). The total value of the items that McCoy selected was \$30.95. McCoy then went to aisle 12 and concealed the items inside of the Publix bag. Menos advised that the subject then went to the register and paid for two gallons of water she had selected. Menos advised that McCoy never attempted to pay for the items concealed in the Publix bag as she passed all points of purchase.

Menos stated that he stopped McCoy and escorted her to the computer room. Once there, Menos learned that McCoy had an outstate identification card. That is when he called for the police. The above mentioned items were recovered by Publix at the same total price.

Menos completed a witness statement and was provided with the case information form. I then proceeded to place McCoy into handcuffs and advised her she was under arrest. The handcuffs were double locked and checked for fit. McCoy was transported to District 16 (2995 S. Jog Road, Greenacres, FL) to be processed. McCoy was later transported to the Palm Beach County Jail.

McCoy was arrested for Petit Theft (Retail) pursuant to F.S.S 812.014 (3)(A).
