On the **14** day of **December** 20 **17** at **0145**  A.M.  P.M. (Specifically include facts constituting cause for arrest.)

**On Wednesday 12/14/17 at approximately 0130hrs I responded to 10328 Boca Entrada Blvd located in unincorporated Boca Raton in reference to a domestic dispute. Upon arrival I made contact with the victim John Meshna and his live-in girlfriend Lauren Prater.**

**Meshna refused to complete a sworn written statement but verbally told me the following: he and Prater got into a verbal argument about him not putting her cell phone back on the charger and about her getting a flat tire earlier in the day. Meshna stated that during the argument Prater punched him in the face and hit him with a Swiffer mop on his right forearm. Meshna stated that he tried to get Prater to leave the residence so he wouldn't have to call the police. Meshna advised me that Prater would not calm down and he called 911. I observed that Meshna had a bruise on his left forearm where he said he was hit with the Swiffer mop. I did not observe any other marks or injuries to Meshna's person.**

**I spoke to Prater who stated that she and Meshna got into a verbal argument. Meshna advised me that she and Meshna separated where meshna was staying in the bedroom and she was staying in the living room. Prater stated that they began texting each other from separate rooms and the argument escalated to becoming physical. Prater stated that she accidentally hit Meshna with the Swiffer mop. Prater denied punching Meshna in the face but stated that earlier in the night he slapped her in the face. I did not observe and marks or injuries to Prater's person.**

**Based on my investigation I determined Prater to be the primary aggressor. I have probable cause to arrest Prater for domestic Violence pursuant to F.S.S. 784.03(1A1). I advised Prater that she was being arrested for Domestic Battery. I placed Prater in handcuffs to the rear. I double locked the cuffs and checked them for proper fit. I then placed Prater in the rear of my marked patrol vehicle and transported her to CJ without incident.**
