On the **21th** day of **December** 20\_\_ at **9:56**  A.M.  P.M. (Specifically include facts constituting cause for arrest.)

On Wednesday, December 21st, 2016, at approximately 2130hrs, I was dispatched to the area of Lake Worth Road and Swain Blvd, in reference to a vehicle blocking the roadway. Upon arrival, I learned that there were two vehicles involved in a minor car accident. I was informed by both drivers that they did not want to do a crash report due to minimal damage. After completing my traffic crash investigation, I began to conduct a criminal investigation due to smell of marijuana coming from within one of the vehicles. The vehicle in question was a 2011 White Mazda 4-door, bearing FL Tag Y05HDG, occupied by the driver, W/F Diana E. Pendola DOB 01/23/1996, and the passenger, W/F Lauren C Senechal DOB 06/19/1995.

I asked both occupants to step to the rear of the vehicle and informed them that I would be searching the car due to the smell of marijuana coming from within it. Lauren then stated that she had smoked marijuana earlier but that there was nothing inside the vehicle now. I then asked her to take the baby out of the vehicle as well. Lauren then asked to get her sweater from the front passenger seat. I allowed her to do so while I watched her. As she was going through her stuff, I observed her move a leopard print bag around and then she grabbed her gray sweater/jacket. Lauren then grabbed the leopard bag with the sweater and as she exited the vehicle, I observed her throw something underneath the vehicle on the passenger side. I then told her to step to the rear of the vehicle and I went around to the passenger side. I immediately looked under the vehicle and saw the same leopard print bag under the vehicle. I grabbed the bag and looked inside.

After looking through the bag, I located a clear blue baggie in the second slot to the right contain several pills. The pills were white in color and shaped like a rectangle. The pills were labeled "xanax" on one side, and "2" on the other side. Inside the bag was a total of three complete pills, and four half piece pills which appeared to have been broken in half.</p> <p>I then took possession of the bag containing the pills and placed them on top of the vehicle. Lauren then uttered that the leopard print bag was not hers, and it belonged to her sister. The fact that she removed the bag and threw it under the vehicle in attempt to conceal establishes knowledge and possession in regards to the pills.</p> <p>Lauren was then asked if she had a prescription for xanax which she stated she did not. I checked up the pills on drugs.com to confirm that it was in fact 2mg xanax/alprazolam pills. The website confirmed that it was, and that it was a schedule 4 narcotic which is illegal to possess without a prescription.</p> <p>The blue clear plastic bag was weighed which returned with a 1.3g total package weight. The pills were then later placed into PBSO evidence. Based off my investigation, there is probable cause to charge Lauren C.
