## PROBABLE CAUSE

On Friday September 2, 2016 I, Trooper N. Tineo was on routine patrol in Palm Beach County on the Florida Turnpike. At approximately 5:22pm, I heard Trooper J. Petrofsky radio I.D. number 1668 called out saying that he was hit. He had been involved in a crash southbound just south of exit 107. I immediately headed north to his location.

Upon my arrival, I observed Palm Beach Gardens Fire Rescue attending to the involved parties on scene. I met with Trooper Petrofsky who advised me that he was inside of his vehicle at the time of the crash on the right shoulder of the road. There was a black male sitting on the right shoulder of the road talking to the paramedics.

Lt. R. Williams later arrived on scene and assumed the crash investigation. During the crash investigation Lt. Williams advised me that the driver of the silver sedan bearing Florida Tag MIZLT had been smoking cigars and had an odor of an unknown alcoholic beverage. I made a passenger side approach and observed the driver to have bloodshot watery eyes with an unknown odor of an alcoholic beverage. The driver was later identified as Lawrence Taylor (DOB 02/04/1959). See crash report for crash details.

Once outside of his vehicle Mr. Taylor was unsteady on his feet and I had to repeat myself when speaking to him. At 8:17pm Lt. Williams advised Mr. Taylor that he had concluded his traffic crash investigation and that now I would be conducting a criminal investigation for driving under the influence. Mr. Taylor stated that he understood and agreed to perform field sobriety exercises. The three standardized field sobriety exercises that were performed were HGN, walk and turn, and the one leg stand. The front emergency lights of the patrol vehicles were deactivated. His performance was poor.

HGN: Lack of smooth pursuit, distinct nystagmus at maximum deviation and on set prior to 45 degrees were all present.

Walk and turn: Mr. Taylor was not able to hold the start position during the instruction phase. For his safety he was told to stand normal while I demonstrated and explained the exercise. When told to put his left foot down with his right foot in front of it touching heel to toe, Mr. Taylor started the exercise before being told to do so. He then put his left foot in front of his right foot. On his way up the line he missed heel to toe on steps 4, 6 and 8. He proceeded to make an improper turn and missed heel to toe on steps 3, 4, 5, 6 and 8. He ended the exercise by taking an in-correct number of steps as he stopped at 11 after being instructed to take 9 heel to toe steps.

One leg stand: Mr. Taylor was not able to hold the start position during the instruction phase. He raised his right foot and on his count of 3, he fell over to his right and put his put down to steady himself. Mr. Taylor then raised his right foot again only to put it back down after his count of 1. He used his arms for balance and put his foot down on his count of 6. At one point Mr. Taylor switched to now keeping his right foot on the ground and elevating his left foot. He had a noticeable sway from side to side and stopped the exercise before being told to do so.

At 8:29pm, I placed Mr. Taylor under arrest for driving under the influence. After being placed in handcuffs he stated that he had just suffered an injury. At the start of this investigation Mr. Taylor was asked if he had any injuries or problems with his eyes that would prevent him from performing the exercises and he stated no. He also refused medical attention on scene.

On our way to the Palm Beach County Jail Mr. Taylor started complaining that he was not feeling well and felt as if he was going to throw up. I stopped my patrol car and asked dispatch to send me EMS. Palm Beach Fire Rescue unit # 23 arrived on scene and evaluated Mr. Taylor. Capt. Earl Brown arrived on scene and transported Mr. Taylor to the Palm Beach County Jail once he was cleared from EMS.

Once the 20 minute observation was complete, Mr. Taylor agreed to provide a breath sample. His results were .082 and .084 nearly 5 hours after being involved in the crash mentioned above. His Miranda rights and implied consent were read on camera at the BAT. When asked what city/county he was in he stated Broward and when asked if he had anything to drink his reply was "apparently too much". There is video available from the BAT and patrol car for the events above.

Mr. Taylor was then transported to Wellington Regional Medical Center to receive medical clearance prior to being admitted into the jail. Once he was cleared at the hospital, Mr. Taylor was then transported back to the county jail. Mr. Taylor was then turned over to the Palm Beach County Jail staff without incident.




