

Desir's supplement for further.</p> <p>I observed signs of impairment; the pungent odor of an alcoholic beverage emanating from Korpeck's person, his speech was slurred, he displayed slow reactions when moving, and his eyes were glassy and red. Korpeck advised that he was coming from Blue Martini and had consumed three glasses of Merlot wine. Korpeck advised that he was depressed about a recent divorce. At one point during the aforementioned investigation Korpeck apologized for driving intoxicated. I explained my observations to Korpeck and asked if he would attempt the field sobriety exercises to dispel my concern that he was operating a vehicle impaired. Korpeck agreed to attempt the exercises. I then asked Korpeck to exit the vehicle and walk to the designated area to perform the exercises. Korpeck used the driver's door to brace himself as he exited the vehicle. The ground was flat and level, and there was a straight painted white line that we could use for a walk and turn exercise.</p> <p>The first task was the Horizontal Gaze Nystagmus. I observed Korpeck's eyes to be bloodshot and glassy. I observed his pupils to be of equal size and have equal tracking of the stimulus. I observed a lack of smooth pursuit in both eyes and in both directions. I observed the onset of nystagmus to be prior to 45 degrees in both eyes and in both directions. I observed a distinct and sustained nystagmus at maximum deviation in both eyes and in both directions. Korpeck turned his head several times to track the stimulus and his body swayed.</p>

The second task was the Walk and Turn. Once we established the starting point for the Walk and Turn, I asked Korpeck if he had any problems which would prevent him from conducting the field sobriety tasks. Korpeck stated he did not. After I gave the instructions to Korpeck at the task at hand, I asked if he understood. He advised he understood and was unable to maintain the starting position during the instructional phase. He did not step heel to toe on every step after step one. He used his arms to balance and did the incorrect number of steps (he counted to 21 steps). During the task he made an improper turn and stepped off the line at step 12.

The third task was the one leg stand. I gave the instructions and demonstrated the task. I asked Korpeck if he had any questions and he advised he did not. Korpeck was unable to keep his arms at his side and swayed on occasion. During the exercise he used his arms to maintain balance. He put his foot down after three seconds and tried unsuccessfully to restart the task until I ended it for his safety as he was swaying and was about to fall over.

The fourth task was the finger to nose task. I gave Korpeck the instructions and demonstrated the task at hand. During the task he used the middle of his index finger to touch his nose instead of the tip of his finger; he held his finger on his nose instead of bringing it down to his side, and on the last sequence of R-L he brought his left finger to his nose instead of his right contrary to my instructions.

The fifth task was the Romberg Alphabet from A to Z in a non-rhythmic manner. During the demonstration he skipped multiple letters. Furthermore, his hands were not at his side and he indicated he understood what non-rhythmic manner is, but persisted to state the alphabet rhythmically. He went from A to H to E I G, to A to H I G, and then he stopped and advised that he did not remember the alphabet and was unable to proceed.

At 0158 hours, based on my observations, I placed Korpeck under arrest for DUI. I then transported Korpeck to the Boca Raton Police holding facility for processing. Officer Deen was inside the holding facility to operate Intoxilyzer 8000 testing. Korpeck refused to provide a breath sample, I read him implied consent, and he refused to provide a breath sample again.

Korpeck was charged pursuant to F.S.S. 316.193(1) DUI on February 23, 2016, in Palm County Florida. The video of the incident was later submitted into BPD evidence. Korpeck was given the court date of March 27, 2017 at 8:30 AM at 200 West Atlantic Avenue Delray Beach, FL. Korpeck was issued a citation for driving under the influence pursuant to F.S.S 316.193(1).

Korpeck's vehicle was towed by Westway Towing. Korpeck told me that he was depressed, wanted to die, and did not deserve to be alive. Korpeck was transported to Palm Beach County Jail.


