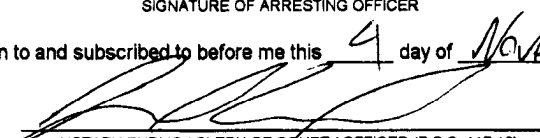

his left arm and shoulder area, and a laceration on upper right side of neck. Mitchell advise he and his girlfriend, Leanna Moore (07/14/93) got in a verbal altercation regarding relationship issues and Mitchell going through Moore's phone, suspecting her of talking to other men. Mitchell stated the argument started overnight and escalated early this morning, he said that he continued to walk away from Moore as she continued to get in his face. Mitchell stated at that time Moore bit him on his arm left arm, shoulder and caused a laceration on the right side of his neck area which caused the injuries stated above. I obtained a sworn victim statement from Mitchell. Mitchell's injuries were consistent with his story

Mitchell advised that him and Moore have been in an on and off relationship for over a year, and that Moore has lived with him at previous addresses in the past. Mitchell had a video that showed Moore as the aggressor at that time by pulling on Mitchell arms and appearing to bite him at one point in the recording. Mitchell will forward the video to this Officer's email to upload into evidence.com.

I met Moore at West Palm Beach Police Department lobby, she was mirandized and stated that this morning she was upset with Mitchell because of ongoing relationship issues, also she was concerned with the videos that Mitchell would record of her when she is sleeping, without her knowledge or permission. Moore advised the same as Mitchell regarding what occurred but does not recall biting Mitchell due to being very agitated at the time. Moore said she did not mean to scratch Mitchell and cause him to bleed. All

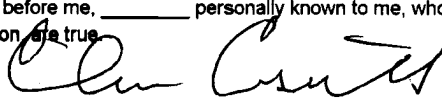
Moore provided sworn statement regarding this matter.

Moore was transported to PBCJ without issues.

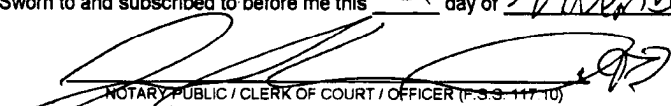
