On the <b>24</b> day of <b>March</b> , <b>2018</b> at <b>00:08</b> (Specifically include facts constituting cause for arrest.)		
On 03/24/18 at 2317 hours, Ofc Codling and I were dispatched to 2140 N Federal Hwy in reference to a domestic disturbance.		
Upon arrival, I met with W/F Leigh Rzasas Ormes DOB 09/04/1953. Leigh stated her and her husband W/M Norvin Ormes DOB 02/26/1948 had been to the Boca Resort and were driving home when they got into an argument. According to Leigh, she struck Norvin with an open back hand to the face when she became enraged. Norvin then hit her in return. Leigh explained Norvin then got out of the car and starting walking north bound on Federal Hwy. I Observed Leigh minor swelling in the corner of her right eye.		
Norivn was located in the area of 2700 N Federal Hwy. I spoke with Norvin who stated that he and his wife had been at the Boca Resort for the night. According to Norvin, Leigh was driving erratic and became enraged when he tried to get out of the car and she struck him with an open hand on his left cheek. Norvin admitted to striking Leigh after the fact. I observed minor swelling on Norvin's left cheek. Norvin refused to complete a written statement.		
Based on my investigation Leigh was arrested and is being charged with F.S.S. 784.03(1A1) Simple Battery, Domestic. Leigh was processed at BRPD then transported to Palm Beach County Jail. Pictures of Leigh and Norvin were taken and placed into evidence. Norvin was given a domestic violence pamphlet and the receipt was forwarded to BRPD records.
