

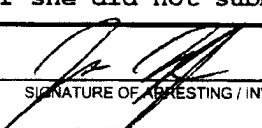

On 12/16/19 at approximately 0032 hours, I responded to 1700 Royal Palm Way in reference to a black Chevrolet SUV that was seen driving erratically and swerving across the road. It was dispatched over the radio that security officers from Royal Palm Yacht and Country Club were present with the vehicle in question and noted that the driver behind the wheel was a woman who was asleep and in the driver's seat. Upon arrival, I met with the security officer who was out with the vehicle, Geovanny Arroyo, who signed a sworn written witness statement advising that he observed the black Chevrolet Tahoe driving Northbound on Royal Palm Way. The driver looked at Arroyo and had a "glazed look" and swerved while turning. The vehicle continued driving while swerving on the street and eventually stopped in the driveway of 1711 Royal Palm Way. When he approached the vehicle, the female driver smiled at him and immediately fell asleep at the wheel. Officer Castillo and I then approached the vehicle and found a W/F, later identified as Leilani Vaglica, seated in the driver seat, asleep and breathing. We knocked on the door and Vaglica opened her eyes, which were red and glassy. When she did so, the keys to the vehicle slipped out of her hands and onto the floorboard. She advised she parked her car in the driveway we were standing in. Officer Castillo could smell the odor of an alcoholic beverage coming from the vehicle as Vaglica was speaking. While Vaglica was attempting to answer our questions, she was slurring her speech. Multiple times during our encounter, Vaglica attempted to take the vehicle out of park and also tried taking the car keys and placing them in the ignition. At this point, we opened the door to her vehicle to prevent her from driving off. Officer Castillo again smelled alcohol coming from Vaglica's breath. Roadside sobriety exercises were offered to Vaglica, and she responded that she wanted to wait for "the cops." It should be noted that Ofc. Castillo and I were dressed in our full police attire with Boca Raton Police patches on our sleeves. Ofc. Castillo advised to Vaglica that if she did not submit to the roadside
