PROBABLE CAUSE

On Wednesday June 27, 2018 at approximately 8:00 PM, I (Officer Baldwin) responded to 117 Lighthouse Circle Unit G with in the Village of Tequesta in reference to a Violation of an injunction for protection against domestic.

Upon arrival, I met with the complainant, Pamela Starusta, who stated that her husband, Leon Starusta, violated his injunction for protection. P. Starusta stated that L. Starusta contacted her via text message. I observed the text message with date and time.

At approximately 10:30 PM, I made contact with L. Starusta, at 220 North US Highway 1 Unit 2(Tequesta Palms Inn) with in the Village of Tequesta in reference to a violation of conditions of pretrial release.

I placed L. Starusta into hand cuffs checking for proper fit and double locking them. I placed L. Starusta in the back seat of my TPD marked patrol vehicle unit 505.

Based upon my investigation, I have reason to believe that the defendants committed Violation of an injunction for protection against domestic violence pursuant to F.S.S. 741.31(4)(A).

ORDER OF NO CONTACT

This "no contact order" is effective immediately and enforceable for the duration of the pretrial release or until modified by the Court.

1. The Defendant is specifically ordered to have NO CONTACT and to not attempt to contact the following person(s):

- Co-Defendant(s) _____

2. The Defendant shall NOT CONTACT or attempt to contact the above-listed person(s) until this case is closed or until further order of the Court, whichever occurs first.

3. For purposes of this Order, "no contact" means:

- NO direct or indirect messages or communications by the Defendant.
- NO direct or indirect contact by a third person on behalf of the Defendant. This does not prohibit an attorney for the Defendant, consistent with Rules regulating The Florida Bar from communicating with any person protected by the no contact order for lawful purposes.
- NO communication of any kind including telephone calls, messages on answering machines and voice or electronic; all written forms of communication, including letters of apology; or any other means of communication, including the delivery of gifts at any time, either at a residence, school, or workplace.
- The Defendant is prohibited from being within 500 feet of the victim's or other named person's residence, even if the Defendant and the victim or other named person share the residence.
- The Defendant is prohibited from being within 500 feet of the victim's or other named person's vehicle, place of employment, or a specified place frequented regularly by such person.
- The Defendant is prohibited from the following addresses (victim's home/job, if child involved school address/aftercare center/address for extracurricular activities):
