<p>On 8/4/2017, at approximately 0124 hours, I was dispatched to the Boca Resort, 501 E Camino Real, Room #342 in reference to a domestic disturbance. Upon arrival, I made contact with numerous subjects.</p> <p>I first spoke with W/M Bradlee Carman. Bradlee explained that he and his family were all staying in a room at the Boca Resort. Bradlee was joking around with his kids and "playful" hitting them. It should be noted that further into the report it explained that Bradlee jokes around with his children by lightly hitting them. All of the children agreed with this and advised that he does not hit them to hurt them and that it is a joke. While this was occurring, Bradlee stated that his one son, W/M Leonard Connor, got upset. Leonard then got up from his bed and ran over to the bed where Bradlee was lying down. Bradlee then got up from his bed and Leonard then put both of his hands around Bradlee's upper shoulder/neck area. At this time, Bradlee pushed Leonard away from him in the chest with both hands. Bradlee stated that Leonard then pushed him to the ground and got on top of him and began holding him down on the ground. Bradlee's wife, W/F Shawn Carman, then got up and began attempting to stop them from fighting by pushing them away from each other. Once the fight was over, Leonard and his siblings left the hotel room and resort security showed up.</p> <p>I spoke with Shawn. Shawn explained that she was lying in bed with her daughter, W/F/J Ellenor Connor, when Bradlee and Leonard began having a verbal argument. Shawn explained that she then saw Leonard get up and run towards Bradlee who was lying in bed. Shawn first stated that she saw Leonard attack Bradlee and then stated that she was unsure who hit whom first. She explained that they both ended up on the ground in a physical altercation; so she began trying to stop them by pushing them away from each other. They stopped fighting and Leonard and her other children went outside of the room and resort security showed up.</p>



	<p>I then spoke with Ellenor, W/F/J Olivia Connor, and W/M/J Jackson Carman. They all advised that Bradlee was playing around by hitting them. They all stated that he does this to have fun with them and at no point did they think he was trying to hurt them. They stated that Leonard got upset and began yelling at Bradlee. Leonard and Bradlee then began yelling at each other, when Bradlee grabbed Leonard by the head with both hands. Leonard pushed Bradlee off of him, which caused him to fall. Leonard got on top of Bradlee and began holding his down until Shawn was able to push them off of each other. They all then left the hotel room and resort security showed up.</p> <p>I then spoke with Leonard. Leonard explained the following: He was upset with how Bradlee was treating his siblings. Leonard began yelling at Bradlee, when Bradlee came up to him and grabbed him by the head with both hands. Leonard then pushed Bradlee away from him in the chest with both hands; which caused him to fall to the ground. Leonard stated that he was scared that Bradlee was going to hurt his siblings and got on top of Bradlee on the ground and held him down with his hands around the upper shoulder/neck area. Shawn then intervened and pushed them away from each other. Leonard then left the hotel room with his siblings and resort security showed up.</p> <p>It should be noted that Bradlee had a scratch on the bottom right side of his chin. Leonard had red markings on his upper chest and shoulders. Photos were taken and dropped into BRPD Evidence.</p> <p>Based on my investigation I placed Leonard under arrest for domestic battery under FSS 784.03(1). Leonard was transported to BRPD booking and then TOT CJ.</p>
